Verbiage has been revised to require subgrade treatments to be shown on the typical sections and the cross sections.
- [SECTION 1305.1 - GENERAL](#)  
Verbiage has been revised to require plan notes to be consistent with the intent and requirements of the plans.
- [SECTION 1307.2.2 - PARTICIPATION AND FUNDING SPLITS](#)  
Participation or funding split columns are to be included on all sheets of the General Summary when participation or funding splits are needed for a project. A note with the details regarding the participation or funding splits shall be provided.
- [SECTION 1307.2.3 - ITEM CODE, UNIT OF MEASURE, AND DESCRIPTION](#)  
Minor verbiage and pay item changes have been made throughout this section. Contact the **Office of Estimating** with questions.
- [SECTION 1307.4.2 - PAVEMENT CALCULATIONS](#)  
Computations shall clearly show how quantities are derived. Quantities shall be carried to the General Summary and listed under "Office Calcs."
- [SECTION 1308.1 - PROJECT SITE PLAN](#)  
A project Site Plan is required for all projects requiring post construction BMPs.

Contact the District Environmental Coordinator regarding if a SWPPP is required for projects which may impact habitats or species.

## SECTION 1400 - REVIEW SUBMISSIONS

## SECTION 1500 - PLAN RELATED ACTIONS

- **SECTION 1502 - DOCUMENTATION OF ENVIRONMENTAL COMMITMENTS**

Completion of the ECF, Environmental Consultation, Form confirms compliance with all environmental commitments and mitigation plans.

In addition to being part of the environmental document, environmental commitments identify responsible parties and required actions.

- **SECTION 1503.1 - CADD SOFTWARE REQUIREMENTS**

Verbiage has been revised to replace specific types of design software (*MicroStation, GEOPAK*) with the name of the company developing the product (*Bentley*).

CADD files shall be developed in accordance with the **Guidelines for Electronic Design Deliverables**.

- **SECTION 1503.2.1 - Typical Requirements for Projects Following Path 1 of the Project Development Process (PDP)**

Path 1 project description has been updated. See **PDP Manual** for more information.

- **SECTION 1504.1.1 - PROJECTS ADMINISTERED BY ODOT**

Electronic image files shall be provided in accordance with the **ODOT Guidelines for Electronic Design Deliverables**.

- **SECTION 1505.1 - PLAN CHECKING**

In addition to the Scope of Services document, the Project Manager shall ensure that the plans are in accordance the **ODOT Guidelines for Electronic Design Deliverables**.

- **SECTION 1506.1.1 - PROJECTS ADMINISTERED BY ODOT**

When submitting a Plan Package, ODOT's electronic plan submittal process must be followed.

Except for the Title Sheet, all pages of PDF plan sets must be in vector format. PDF files shall not be rasterized.
