Please see attached for ODOT's ROW plan that shows the preliminary layout of the widening and roundabout. This project is a design-build project and the design is not final. There is a good chance the final design conflicts with the duct bank AT&T has running along SR-435 on the south side. The Design Build Team that is awarded the contract will determine this in early stages of design; and I assume a

likely scenario would be that AT&T has to relocate from MH NO 11539 all the way down to SR-729 at MH NO 11280.

How long (approximately) would it take AT&T to re-design a relocation plan from the day they are given notice of the conflict? How long (approximately) would it take AT&T to complete the relocation work once the permit has been approved by ODOT. This does not have to be exact, but I am just seeking a reasonable estimation of # of days.


