Dear Ms. Fahy:

We have reviewed the above-mentioned project and have determined that the project will encroach into the 100:1 (1407.1.2) notification surface. This determination is based on an airport elevation of 671 feet, and heliport elevation of 661 feet, a project elevation of 652 feet, with a distance of 11,611 feet between the airport and the project locations. The attached diagram and spreadsheet will provide a detailed analysis of the study. The study has also determined that a height of 85.11' exists between 100:1 notification surface and the project. Therefore, based on this height and the heights from Figure 1407-3, plan note G118A will not be required.
