Altafiber

Altafiber has facilities within the project limits. All underground cables will be abandoned after relocation is complete. Conduit and cable attached to Linn Street bridge to remain after relocation and to be removed by ODOT contractor. Relocation work to be completed by December 31, 2025. Duke Energy Electric Distribution

Duke Energy Electric has facilities within project limits. Conduit crossing interstate at approximately Sta. 758+50 of Centerline of Winchellwill be rerouted and abandoned. Duke Energy will be rerouting to Linn Street to Liberty Street to Western Avenue with a combination of overhead and underground. This work will be complete by February 28, 2026.

The Duke electric lines along the south side of Gest Street will likely conflict with the clearance requirements for construction equipment for removal and/or installation of the Linn Street bridge. Contractor must maintain at least 20 feet of clearance between equipment and electric lines. If clearance cannot be maintained, Contractor must reach out to Duke a minimum of thirty (30) days prior to work commencing for Duke to de-energize the lines.
