PROTECTION OF BATS-CUTTING RESTRICTIONS:

THE PROJECT IS LOCATED WITHIN THE KNOWN HABITAT RANGES OF THE FEDERALLY LISTED AND PROTECTED INDIANA BAT AND NORTHERN LONG-EARED BAT. THE CONTRACTOR SHALL NOT REMOVE TREES UNDER THIS PROJECT FROM APRIL 1
THROUGH SEPTEMBER 30. ALL NECESSARY TREE REMOVAL SHALL OCCUR FROM OCTOBER 1 THROUGH MARCH 31. THE CONTRACTOR SHALL DEMARCATE CLEARING LIMITS TO THE FIELD TO AVOID ANY UNAUTHORIZED TREE CLEARING. APPLY SEEDING AND MULCHING TO ALL AREAS OF EXPOSED SOIL BETWEEN THE RIGHT-OF-WAY LINES AND WITHIN THE CONSTRUCTION LIMITS FOR AREAS OUTSIDE THE RIGHT-OF-WAY LINES COVERED BY WORK AGREEMENT OR SLOPE EASEMENT. THE CONTRACTOR SHALL USE NATIVE/WILDFLOWER SEED MIX PER ITEM 659.09 CLASS 4, 5, OR 6 FOR SEEDING BETWEEN THE BRIDGE APPROACH SLABS AT STA. 12+34.50 AND STA. 12+97.50. QUANTITY CALCULATIONS FOR SEEDING AND MULCHING ARE BASED ON THESE LIMITS.
