## LTAP eLearning Training Updates <u>Scope of Services</u>

The Ohio Department of Transportation's (ODOT) Office of Local Programs (OLP), via the Ohio Local Technical Assistance Program (LTAP) Center, provides an extensive online training program, with curriculums focused on various technical areas within ODOT. These courses have made our available training more accessible and efficient for the transportation community. We are seeking assistance with updating some of our courses, based on technical changes in content and length of time since original publication.

## **Background:**

ODOT>OLP>LTAP provides over 750 different eLearning courses for Ohio's Local Public Agency (LPA) community. These courses include various subjects which are required in order for LPAs to apply for and receive Federal project funding. The courses also include prequalification training for the consultant and contractor community in Ohio who seek to perform work for ODOT and LPAs. Traditionally, these training courses were held inperson and ranged from a half (1/2) day to multiple days. Our customers have stated that the eLearning format is much more conducive to training completion. The selected consultant must be familiar with ODOT>OLP>LTAP's catalog of training courses and the target course audiences.

The services provided will include:

- Using Storyline (or Lectora) eLearning software to:
  - o Convert existing eLearning training courses to an updated format
  - o Develop a new curriculum for Ellis and create eLearning training course
  - Incorporate subject matter changes into the existing modules
  - Incorporate subject matter changes into the new modules
- Trainings must:
  - Follow ADA guidelines
  - Reference technical training information shared by subject matter experts and/or LTAP

- Reference manuals and guidance documents as appropriate for the technical area
- The consultant will be responsible for:
  - Reviewing files for completeness
  - Quality assurance review of files
  - Work in cooperation with LTAP and subject matter experts in updating of training materials
  - Work in cooperation with LTAP and subject matter experts in creating of training materials
  - Providing bi-weekly status reports, detailing the status of all active projects
  - Meeting with LTAP staff and subject matter experts weekly to review training materials under redevelopment

## **Qualifications**

- The consultant shall maintain a project cost accounting system that will segregate costs for individual task orders.
- The price proposal shall consist of a statement from the consultant that they
  have a clear understanding of the scope of services. The proposal shall include
  the names and starting hourly rates of the personnel doing the work and
  beginning consultant overhead rate, plus the average ODOT overhead rate to
  calculate net fees.
- A proposal by cover letter from the subconsultant to the prime consultant showing hourly rates, beginning overhead rate, average ODOT overhead rate to calculate net fees; and all services and unit prices shall also accompany the proposal.
