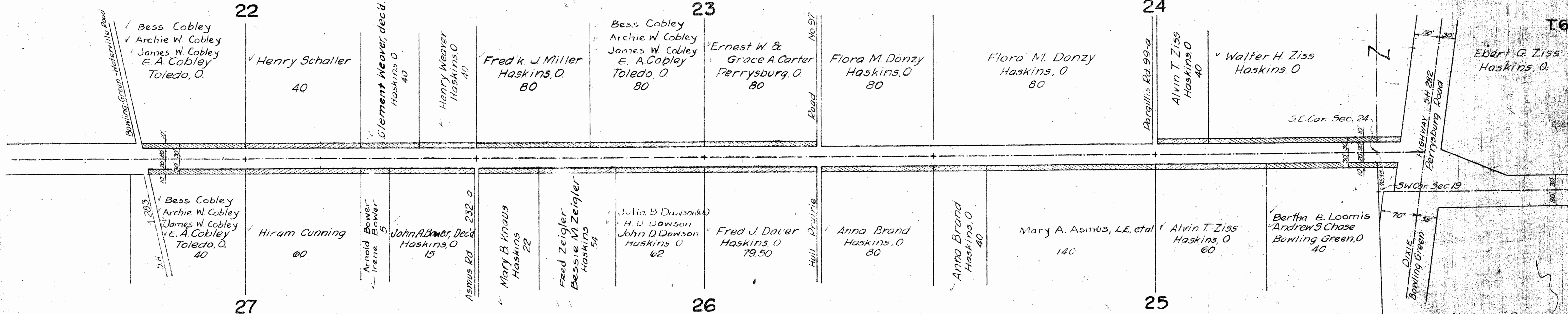


TOWN 6 NORTH RANGE 10 EAST

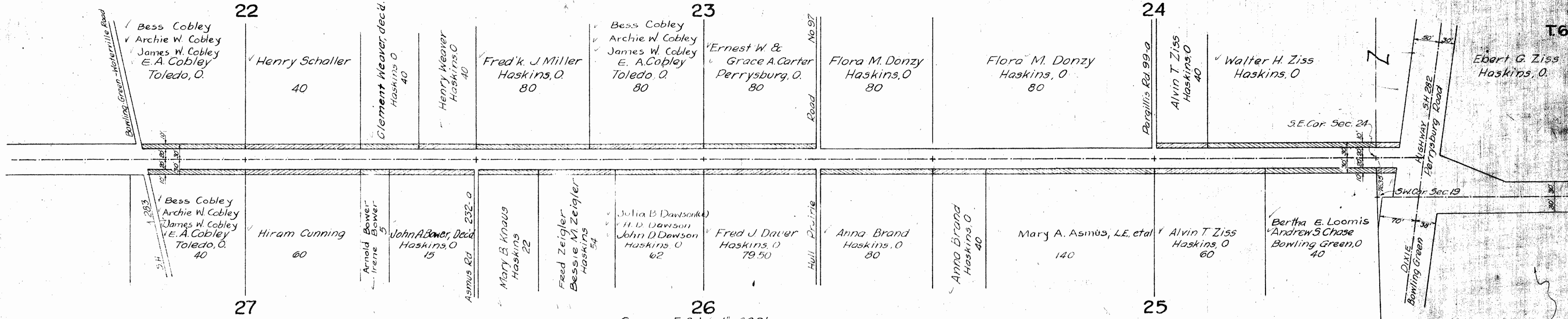
