As we discussed; ODOT does not require the removal of the referenced billboard for our current project identified as PID 110412 FAI SR 37 06.10 (SR 37/256 intersection improvement). Although the billboard is now overlapping the new R/W; it was not recognized as an 'encroachment' due to the <u>timing</u>. It is also noted that the base of the billboard and the monopole are outside of the R/W. ODOT did not acquire the billboard, did not pay just compensation for this billboard, and did not have a taking from the billboard owner. Here are some dates for your records:
