ODOT met with R/W designer and received some details that I can share.

We have a list of parcels that you can move forward with closing and recording. These parcels will use the legal description previously provided. It is ten parcels with five having checks drawn. Here are the parcels:

- 12
- 15
- 17
- 19
- 20
- 22
- 28
- 30
- 31
- 32

According to our records, we sent you warrants for 19 (already recorded as confirmed with online recorder) and parcels 12, 15, 22, & 30. Those can be closed and recorded when property owner is able.

FYI that Stage 3 plans are uploaded in REAL OS. I expect the remaining parcels legal descriptions and revised plans in January (likely late January).

Please let us know when parcel 19 is vacant, RE-95-R is signed, and Asbestos testing completed. Please let me know when 18 billing package is in REAL OS and when you need the check for closing. Hopefully, they have started the moving process on 19 as that house needs down soon (within 90 days preferred). Thank you!

- PCL 29 not staked yet as they want to finish the U legal descriptions 1st.
- ODOT is meeting with R/W consultant on Monday regarding U legal descriptions as they are not done yet.

- I was verbally told that the 18-U1,2 and 19-U1,2 might need to change due to connectivity of the easement corridors (will know Monday) ... I would hold on the recordings, although you can still close and give owner the proceeds as we discussed.
- I do need a billing package in REAL OS for 18 Young.

Hi Megan,

We can Stake 29 but survey likes to stake once for all needed. Please provide a list of all that need staked as to send survey out one time to capture all needed. Thank you.

27-T & 29-T are for tree removal overlapping the UV. ODOT will remove the Trees ahead of the Utility Company using their U..

Utilities will need tree clearing between now (as soon as we get all parcels cleared) and end of March preferred (due to the environmental bat tree rules) or as soon thereafter as possible (i.e., ASAP). The Utilities can relocate as soon as we have possession and trees cleared. They need to be moved before construction (i.e., spring or early summer of 2025).

Mailboxes are placed by contractor at USPS instruction. It is unlikely that it will be in a drive, but likely close to it. It is subject to change based on USPS direction.
