Being a sanitary sewer easement over and under the following described property:

Situated in the Township of Perry, County of Franklin and State of Ohio, more particularly described as follows:

Being part of Lot No. 1, Tuller's Survey of Section 1, Township 2, Range 19, United States Military Lands and being part of a certain 9.24 acre tract conveyed to James D. Miller and Jean C. Miller by deed of record in Deed Book 1792, Page 532, records of the Recorder's Office, Franklin County, Ohio and being a permanent easement, 15.0 feet wide, the centerline of which being described as follows:

Beginning for reference at a point in the centerline of SNOUFFER ROAD, said point being the southwest corner of said 9.24 acre tract, said point being also the southeast corner of that 38.904 acre tract conveyed to GREENLEAF, INCORPORATED by deed of record in Deed Book 2931, Page 611; thence, northerly with the easterly line of said 38.904 acre tract N 4°-46'-46" W, 47.62 feet to the TRUE POINT OF BEGINNING of this herein described 15.00 foot permanent easement;

thence, from the TRUE POINT OF BEGINNING, easterly N 89°-16'-37" E, parallel with and 47.5 feet northerly from (as measured at right angles) the centerline of said SNOUFFER ROAD, for a distance of 486.22 feet to a point, said point being N 12°-15'-16" W, 48.48 feet from the intersection of the westerly right-of-way (100.0 feet in width) for the Chesapeake & Ohio Railway and the centerline of said SNOUFFER ROAD, said point being also the terminal point of the herein described easement.

Construction Easement

Also a construction easement for use only during the construction of a sewer within the said permanent easement, an additional area of land alongside said permanent easement to the extent of limiting lines described as follows:

The westerly limiting line being the westerly property line of said 9.24 acre tract, said westerly limiting line being also the easterly line of a tract having been conveyed to GREENLEAF, INCORPORATED by deed of record in Deed Book 2931, Page 614, Recorder's Office, Franklin County, Ohio; the easterly limiting line being the westerly line of the Chesapeake & Ohio Railway; the southerly limiting line being a line parallel with the centerline of Snouffer Road and 55.0 feet northerly (As measured at right angles); the northerly limiting line being a line parallel with the centerline of Snouffer Road and 75.0 feet northerly (as measured at right angles).

Provided, and this instrument is executed and delivered upon the express condition, that nothing herein shall affect, alter or impair, or be construed as affecting, altering or impairing, the lien and encumbrance of the said Indenture of Mortgage and Deed of Trust, as supplemented and amended, upon any of the remaining property now subject thereto; and the

undersigned Trustee hereby expressly reserves and retains all its rights, title and interest as such Trustee under the said indenture of Mortgage and Deed of Trust, as supplemented and amended, in and to all such remaining property, as heretofore.
