Responses to your bullet points are as follows:

- The ODNR contact information will be updated in the plans.
- ODOT will maintain the structure over US68 (span #1)-minus any decorative elements (i.e., lighting, emblems, etc.) and all roadway related items located within the state RW.
- The gravel currently located on the future parking lot area will be stockpiled for ODNR's future use. If you recall, the area currently available to construct this project is very limited. If ODOT's contractor were to install a permanent gravel parking lot using the current gravel on site, or any additional hard surface material, the overland surface flow BMP thresholds would be exceeded requiring the construction of a retention facility. Under the current project limits, there is no available space to construct this element. If the parking area remains as a grass area, then no retention facility is required. The understanding was that as ODNR continues to purchase surrounding parcels, sufficient land area would then be available for ODNR to make any future improvements, including a paved parking lot and retention facility. For this project the gravel will have to be removed and stockpiled.

Here is a summary of our comments/questions:

- Brant Fulks: Please update contact information: Ivy Ortman, [Ivy.Ortman@dnr.ohio.gov](mailto:Ivy.Ortman@dnr.ohio.gov), (937) 629-1740 (previous Park Manager Tim Pritchard is no longer with ODNR)
- Holly Boyer: The MOA only discusses maintenance responsibilities or requirements regarding the bridge structure, there is no mention of who will be responsible for the stormwater BMP. The plans and report identify using a manufactured water quality structure, type 2, for quality treatment. These do require periodic cleaning to function properly. I believe it is shown on the SH right of way and would expect that ODOT plans to maintain it.
- Evanoo/Fulks: The intent of ODNR is to retain the remaining portion of the project area for parking after the bridge is constructed. ODNR asks for the gravel to remain (do not remove the gravel and seed as the plans indicate) and do not remove the existing curb cut and install new curb.
