Section has been revised to remove references to TIFF images and to require that plans be submitted to ODOT in a **PDF** electronic image format. All text-based documents should be provided in a searchable PDF file.

Added **MCRO – Microsurface** to the list of project types.

Provide the design live load (HL-93) with the future wearing surface load (60 psf) information on the Culvert Detail Sheet or Site Plan for precast reinforced concrete box culverts (spans 14 feet or greater), precast reinforced concrete three-sided flat-topped culverts, precast reinforced concrete arch culverts, and precast reinforced concrete round sections. Contact the Office of Hydraulic Engineering with questions.
