Situate in Zimmermans Virginia Military Survey No. 910, Village of Williamsburg, Clermont County, State of Ohio and being more particularly described as follows:

**COMMENCING** at the centerline intersection of East Main Street and Dela Palma Road as shown on Ohio Department of Transportation plan CLE-32-(16.02-16.58), Thence along the centerline of East Main Street along a curve the to the right having a radius of 763.94 feet, central angle of  $05^{\circ}12'43''$ , arc length of 69.49 feet, the chord of said arc bears South  $37^{\circ}21'32''$  East, 69.47 feet; Thence continuing along said centerline, South  $34^{\circ}45'11''$  East, 38.25 feet; Thence leaving said centerline, South  $55^{\circ}18'27''$  West, 30.00 feet to a point in the southwesterly right of way line of East Main Street; Thence along the southwesterly line of said East Main Street the following five (5) courses: 1) South  $34^{\circ}45'11''$  East, 166.20 feet, 2) South  $29^{\circ}53'33''$  East, 59.01 feet, 3) South  $25^{\circ}22'18''$  East, 91.20 feet, 4) South  $37^{\circ}37'07''$  East, 181.20 feet, 5) South  $38^{\circ}46'36''$  East, 449.87 feet to a point in the northerly line of the Grantor, said point being the **POINT OF BEGINNING**;

Thence along said southwesterly line of East Main Street, South  $38^{\circ}46'36''$  East, 34.93 feet AND South  $41^{\circ}28'00''$  East, 23.50 feet;

Thence through the lands of the Grantor, North  $52^{\circ}49'08''$  West, 58.64 feet to a point in the northerly line of the Grantor;

Thence along the northerly line of the Grantor, North  $44^{\circ}38'57''$  East, 13.21 feet to the **POINT OF BEGINNING**.

**CONTAINING 0.0084 ACRES.** Together with and subject to all easements of record.


