Subject: GRE-35-2.41, ADA Ramp Revisions

Ana:

You, me and Kipp Boone met at the GRE-35 project site last Thursday, 8/7/03, to review the ADA ramps at the intersection of N. Fairfield Rd. and Daytona Drive. Though the ramps technically meet the ADA standards, some of the specific site orientations can be improved, especially for the visually impaired pedestrian. This concern was expressed by Mark VonderEmbse of FHWA, therefore revisions to the ramps are being considered. There are 3 ADA ramps at this intersection that are being reviewed, located in the SW, NW, and NE quadrants of the intersection.

Attached are 6 pdf files depicting the existing and revised ADA ramp configurations at each of the three intersection quadrants. The revisions are based on input I received from our in-house ADA expert, as well as our discussion in the field. I believe we were all in agreement that these revisions will address the concerns.

Please review these pdf files and coordinate the review with Mr. VonderEmbse. Please let me know if I can be of further assistance.
