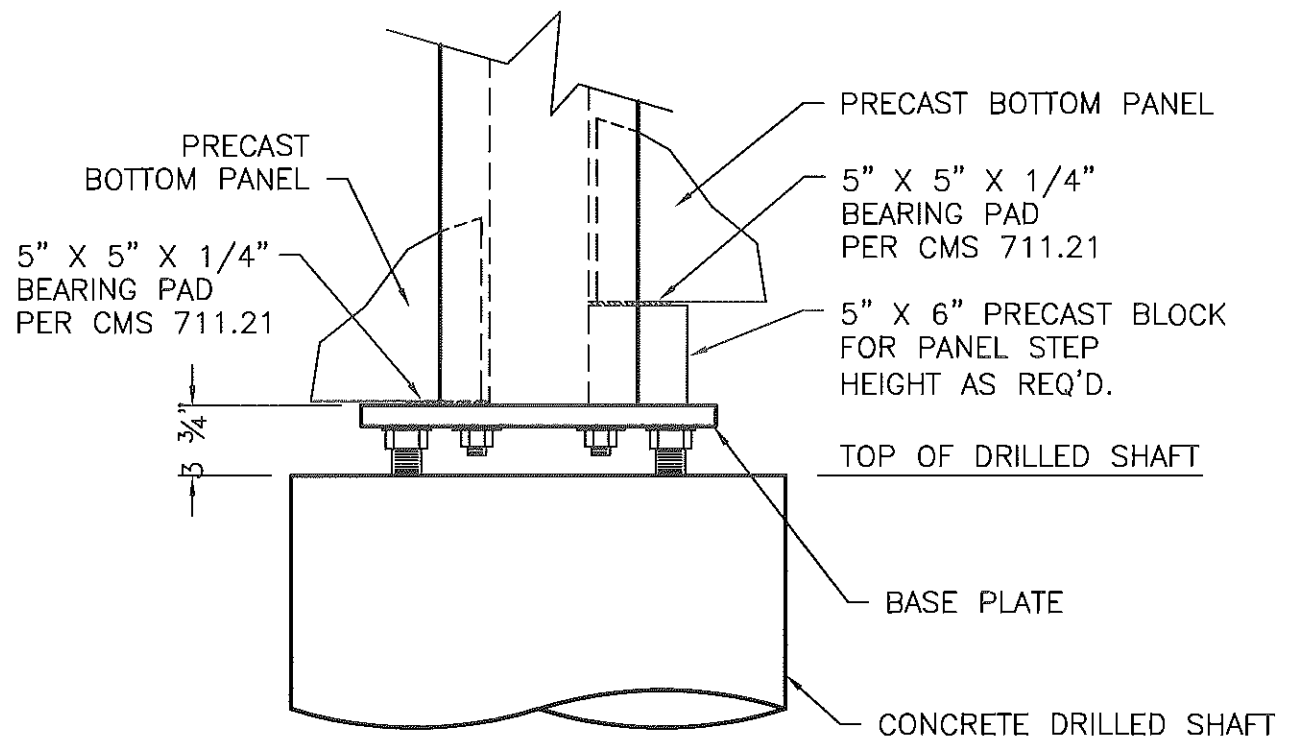


PANEL DESIGNATION KEY



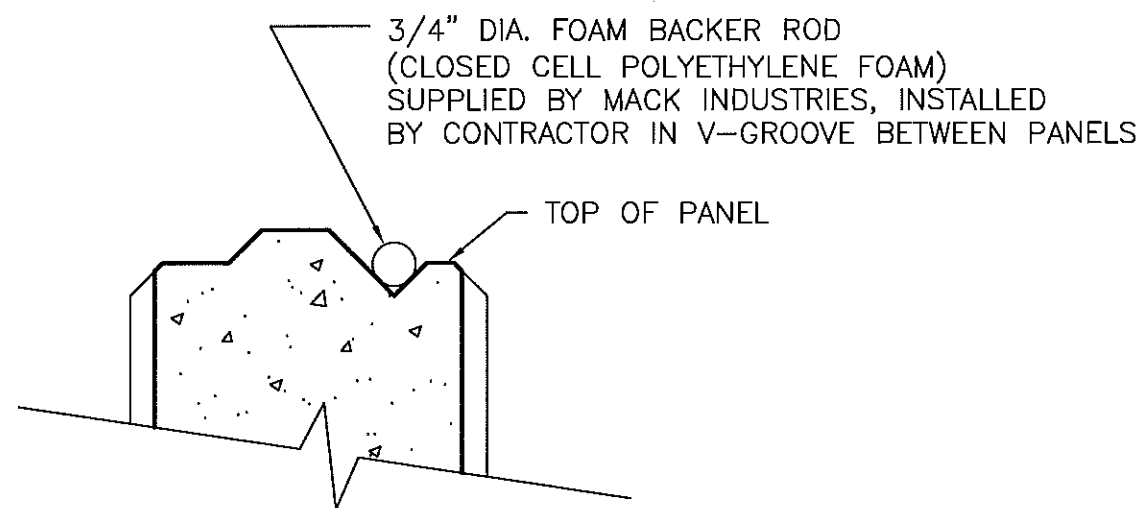
PLAN VIEW
