IN ADDITION TO THE REQUIREMENTS OF ITEM 653, ITEM 659, AND ITEM 661, LANDSCAPING WORK SHALL ALSO CONFORM TO THE FOLLOWING NOTES:

- GENERAL LANDSCAPE NOTES:
 1. PLANT MATERIAL TO BE INSTALLED AND MAINTAINED BY A QUALIFIED AND EXPERIENCED LANDSCAPE INSTALLER.
- 2. ALL PLANT MATERIALS ARE SUBJECT TO THE APPROVAL OF THE LANDSCAPE ARCHITECT AND OWNER. STAKE ALL PLANT LOCATIONS FOR REVIEW AND APPROVAL BY THE ENGINEER AND OWNER PRIOR TO PLANTING. ON-SITE ADJUSTMENTS MAY BE REQUIRED.
- 3. PLANTS ARE TO BE FRESHLY DUG. TRANSPORTING OF PLANTS SHALL BE DONE IN A MANNER AS TO NOT DESTROY THE NATURAL SHAPE, COMPROMISE THE HEALTH, OR ALTER THE CHARACTERISTICS OF PLANT MATERIALS.
- 4. ROOTBALLS SHALL MEET OR EXCEED SIZE STANDARDS AS SET FORTH IN 'AMERICAN STANDARDS FOR NURSERY STOCK'. MAIN LEADERS OF ALL TREES SHALL REMAIN INTACT. REMOVE FROM THE SITE ANY PLANT MATERIAL THAT TURNS BROWN OR DEFOLIATES WITHIN TEN (10) DAYS AFTER PLANTING. REPLACE IMMEDIATELY WITH APPROVED SPECIFIED MATERIAL.
- 5. PLANT COUNTS INDICATED ON DRAWINGS ARE FOR CONTRACTOR'S INFORMATION. CONTRACTOR SHALL MAKE THEIR OWN PLANT QUANTITY TAKEOFFS USING DRAWINGS, SPECIFIATIONS, AND PLANT SCHEDULE REQUIREMENTS, UNLESS OTHERWISE DIRECTED BY LANDSCAPE ARCHITECT. CONTRACTOR TO VERIFY BED MEASUREMENTS AND INSTALL APPROPRIATE QUANTITIES AS GOVERNED BY PLANT SPACING PER SCHEDULE.
- ALL PLANT BEDS SHALL RECEIVE 3" MINIMUM OF SHREDDED HARDWOOD BARK MULCH (UNLESS OTHERWISE NOTED). APPLY PRE-EMERGENT HERBICIDE AS DIRECTED BY THE MANUFACTURER PRIOR TO INSTALLING MULCH. SEED ALL AREAS DISTURBED BY CONSTRUCTION ACTIVITIES THAT ARE NOT OTHERWISE NOTED TO RECEIVE PAVEMENT, PLANTING BED, OR OTHER TREATMENT.
- THE CONTRACTOR WILL INSTALL AND/ OR AMEND TOPSOIL IN ALL PROPOSED PLANT BED AREAS TO MEET ASTM D5268 STANDARDS. A MINIMUM OF 12" OF TOPSOIL IS REQUIRED FOR PLANT BEDS. TOPSOIL SOURCES MAY INCLUDE THE REUSEOF SURFACE SOIL STOCKPILED ON SITE WHICH IS CLEAN OF ROOTS, PLANTS, SOD, STONES, CLAY LUMPS, AND OTHER EXTRANEOUS OR FOREIGN MATERIALS LARGER THAN 1". SUPPLEMENT WITH IMPORTED TOPSOIL FROM OFF-SITE SOURCES WHEN QUANTITIES ARE INSUFFICIENT. DO NOT OBTAIN SUPPLEMENTAL TOPSOIL FROM AGRICULTURAL LAND, BOGS, OR MARSHES. INORGANIC AMENDMENTS, ORGANIC AMENDMENTS, AND FERTILIZERS SHALL BE LISED TO AMEND TOPSOIL AS NEFIED FOR LONG-TERM PANT HEALTH BE USED TO AMEND TOPSOIL AS NEEDED FOR LONG-TERM PANT HEALTH.
- VERIFY ALL UTILITY LOCATIONS IN THE FIELD PRIOR TO BEGINNING WORK. REPAIR ALL DAMAGED UTILITIES TO SATISFACTION OF THE OWNER AND OPERATING UTILITY AGENCY AT NO ADDITONAL COST.
- INSTALL ALL PLANT MATERIAL IN ACCORDANCE WITH ALL LOCAL CODES AND ORDINANCES. COORDINATE WITH THE OWNER TO OBTAIN ANY REQUIRED PERMITS NECESSARY TO COMPLETE WORK. ALL WORKMANSHIP AND MATERIALS WILL BE GUARANTEED BY THE CONTRACTOR FOR A PERIOD OF ONE (1) CALENDAR YEAR AFTER FINAL ACCEPTANCE.
- 10. MAINTAIN ALL PLANT MATERIAL IN ACCORDANCE WITH ITEM 661. MAINTENANCE WILL INCLUDE PRUNING, CULTIVATING, WATERING, WEEDING, FERTILIZING, RESTORING PLANT SAUCERS, SPRAYING FOR DISEASE AND INSECTS, AND REPAIRING ANY TREE SUPPORTS. LONG-TERM MAINTENANCE PROCEDURES WILL BE PROVIDED TO THE OWNER BEFORE EXPIRATION OF THIS PERIOD.
- 11. PAYMENT FOR ITEM 690 DECORATIVE STONE AND METAL EDGING INCLUDES ALL COSTS FOR FURNISHING AND INSTALLING THE DECORATIVE STONE, GEOTEXTILE FABRIC, AND METAL EDGING AS SHOWN ON THE PLANS.

PERENNIAL PLANTING NOTES:

- 1. PERENNIAL PLANTINGS TO BE SPACED 2' ON CENTER THROUGHOUT THE
- 2. INDIVIDUAL PERNNENIAL TYPES TO BE SPREAD EVENLY THROUGHOUT EACH
- 3. DEPENDING ON THE SIZE OF THE PERENNIAL PLANTING AREA, INDIVIDUAL PERENNIAL TYPES TO BE GROUPED IN SINGLE PLANTS IN SMALLER AREAS, A MAXIMUM OF DOUBLE MEDIUM SIZED PLANTING AREAS, AND MAXIMUM GROUPINGS OF THREE OF THE SAME TYPE OF PERENNIAL IN LARGER PLANTING AREAS.
- 4. LOWER GROWING PERENNIALS TO BE PLACED AROUND THE EDGES OF INDIVIDUAL PLANTING AREAS.
- 5. EACH PLANTING AREA SHALL BE LAID OUT WITH PLANTS PRIOR TO BEGINNING PLANTING OPERATIONS SO THE AREA CAN BE REVIEWED TO CONFIRM THE OVERALL MIXING OF PERENNIAL TYPES.
