

**Earth Disturbed Area:**

EDA = 2.64 AC

**Treatment Required:**

T% = 20% (Redevelopment, no new impervious in new permanent R/W)  
 T<sub>Req.</sub> = 0.53 AC

**BMP Calculations (Manufactured System):**

$$WQ_F = (C) * (i) * (A)$$

A<sub>Total</sub> = 0.57 AC (Total contributing area)  
 A<sub>Imp.</sub> = 0.57 AC (Contributing impervious area) (C = 0.9)  
 A<sub>Per.</sub> = 0 AC (Contributing pervious area) (C = 0.3)  
 C<sub>Comp.</sub> = 0.9

Overland Flow

Equation 1:

$$t_o = \frac{(1.8) * (1.1-C) * (L)^{1/2}}{(s)^{1/3}}$$

Where: t<sub>o1</sub> = Time of Concentration (minutes)  
 C = Coefficient of runoff  
 L = Distance to most remote location in drainage area (feet)  
 s = Overland slope (percent)

Shallow Concentrated Flow

Equation 2:

$$V = (3.28) * (k) * (s)^{0.5}$$

Where: V = Velocity (fps)  
 k = Intercept coefficient  
 s = Overland slope (percent)

Equation 3:

$$t_s \text{ or } t_d = \frac{L}{(60) * (V)}$$

Where: t<sub>s</sub> or t<sub>d</sub> = Time of Concentration (minutes)  
 L = Flow length (feet)  
 V = Velocity (fps)

Time of Concentration #1 (Overland Flow):

$$C = 0.9$$

$$L = 285 \text{ ft}$$

$$s = 0.53 \%$$

$$t_o = \frac{(1.8) * (1.1-0.9) * (285)^{1/2}}{(0.53)^{1/3}} = 7.5 \text{ min.}$$

Time of Concentration #2 (Pipe Flow; D2-D3):

$$k = 0.619 \quad (\text{L\&D, Vol. 2, Table 1101-1; Paved area})$$

$$L = 63 \text{ ft}$$

$$s = 1.43 \%$$

$$V = (3.28) * (0.619) * (1.43)^{0.5} = 2.43 \text{ fps}$$

$$t_s = \frac{63}{(60) * (2.43)} = 0.4 \text{ min.}$$

Time of Concentration #3 (Pipe Flow; D3-D3)

$$k = 0.619 \quad (\text{L\&D, Vol. 2, Table 1101-1; Paved area})$$

$$L = 275 \text{ ft}$$

$$s = 0.32 \%$$

$$V = (3.28) * (0.619) * (0.32)^{0.5} = 1.15 \text{ fps}$$

$$t_s = \frac{275}{(60) * (1.15)} = 4 \text{ min.}$$

$$t_c = 7.5 + 0.4 + 4 = 11.9 \text{ min.}$$

$$i = 1.68 \text{ in/hr} \quad (\text{L\&D, Vol. 2, Figure 1115-3, using } t_c \text{ of 12 min})$$

$$WQ_F = (0.9) * (1.68) * (0.57) = 0.86 \text{ cfs}$$
