I just wanted to give you a copy of the PID 102858 prints with Centurylink facilities highlighted. It doesn't seem that we have any facilities in conflict with ODOT plans. All of CTL cables are marked with Do Not Disturb annotations on the prints.

I only have one concern. According to our records, our 48 fiber cable at the Milton-Newton Rd location doesn't go aerial like over I-76, like our 200 pr copper, but it continues buried under it. It doesn't seem to be what the ODOT prints reflect. From what I can tell off of Google Maps from the street view of I-76, the fiber doesn't look overlashed to our copper and seems to support our records.
