STREAM 1 AVOIDANCE

UNDER NO CIRCUMSTANCES SHALL THE CONTRACTOR IMPACT STREAM 1 AS INDICATED IN THE PLAN. NO EXCAVATION. GRADING OR FILLING OPERATIONS SHALL BE PERFORMED IN STREAM 1. A QUANTITY OF ITEM 832 CONSTRUCTION FENCE AND A QUANTITY OF ITEM 832 PERIMETER FILTER FABRIC FENCE HAVE BEEN INCLUDED IN THE GENERAL SUMMARY. THE CONSTRUCTION FENCE AND PERIMETER FILTER FABRIC FENCE SHALL BE INSTALLED ALONG THE PROPOSED CONSTRUCTION LIMITS AT STREAM 1 LOCATIONS BY THE CONTRACTOR PRIOR TO THE START OF ANY CONSTRUCTION ACTIVITIES WITHIN THE LIMITS AND ADJACENT AREA, INCLUDING ANY NECESSARY CLEARING AND GRUBBING ACTIVITIES. STREAM 2 IMPACT (EASTBOUND REST AREA) AND AVOIDANCE (WESTBOUND REST AREA)

UNDER THE DIRECTION OF THE PROJECT ENGINEER, THE CONTRACTOR MAY IMPACT/PLACE TEMPORARY AND PERMANENT FILLS IN STREAM 2 AT THE EASTBOUND REST AREA AS INDICATED IN THE PLAN. UNDER NO CIRCUMSTANCES SHALL THE CONTRACTOR IMPACT STREAM 2 AT THE WESTBOUND REST AREA AS INDICATED IN THE PLAN. THE CONTRACTOR SHALL CAREFULLY REVIEW AND COMPLY WITH ALL WATERWAY PERMIT CONDITIONS PROVIDED AS SPECIAL PROVISIONS.

PAYMENT FOR ITEM 832 CONSTRUCTION FENCE AND ITEM 832 PERIMETER FILTER FABRIC FENCE WILL BE MADE UNDER ITEM 832, EROSION CONTROL. THE CONSTRUCTION FENCE AND PERIMETER FILTER FABRIC FENCE SHALL BE INSTALLED ALONG THE PROPOSED CONSTRUCTION LIMITS AT THE STREAM 2 LOCATIONS BY THE CONTRACTOR PRIOR TO THE START OF ANY CONSTRUCTION ACTIVITIES WITHIN THE LIMITS AND ADJACENT AREA. ALL TEMPORARY FILL MATERIALS SHALL BE DISPOSED OF IN ACCORDANCE WITH 105.16 AND 105.17 OF THE CMS WITH APPROVAL OF THE ENGINEER. TEMPORARILY IMPACTED STREAM 2 CHANNEL AREAS SHALL BE RESTORED TO THE SATISFACTION OF THE ENGINEER.

QUALITY STRUCTURE, TYPE 4.

THE WESTBOUND WQ UNIT WILL BE INSTALLED ADJACENT TO A 108" BASE I.D. NO-3 MH WITH A 12" DIVERSION WEIR. THIS MANHOLE SHALL BE PAID FOR AT THE UNIT BID PRICE FOR MANHOLE. NO.3.

ENDANGERED SPECIES HABITAT - INDIANA BAT/NORTHERN

THE PROJECT IS LOCATED WITHIN THE KNOWN HABITAT INDIANA BAT AND NORTHERN LONG-EARED BAT. NO TREES SHALL BE REMOVED TO CONSTRUCT THE PROJECT FROM APRIL 1 THROUGH SEPTEMBER 30 ALL NECESSARY TREE 31. THIS REQUIREMENT IS NECESSARY TO AVOID AND ENDANGERED SPECIES ACT. FOR THE PURPOSES OF THIS NOTE, A TREE IS DEFINED AS A LIVE, DYING, OR DEAD IN DIAMETER AT A HEIGHT OF 4.5 FEET ABOVE THE GROUND SURFACE. AND WITH A MINIMUM HEIGHT OF 13 FEET.

WETLANDS AVOIDANCE

WETLANDS ARE PRESENT IN PROXIMITY OF THE OF THE PROJECT CONSTRUCTION LIMITS, BEST MANAGEMENT PRACTICES SHALL BE EMPLOYED TO AVOID IMPACT TO WETLANDS AS INDICATED IN THE PLAN. A QUANTITY OF ITEM 832 CONSTRUCTION FENCE AND A QUANTITY OF ITEM 832 PERIMETER FILTER FABRIC FENCE HAVE BEEN INCLUDED IN THE GENERAL SUMMARY. THE CONSTRUCTION FENCE AND PERIMETER FILTER FABRIC FENCE SHALL BE INSTALLED ALONG THE PROPOSED CONSTRUCTION LIMITS AT THE WETLAND B LOCATION BY THE CONTRACTOR PRIOR TO THE START OF ANY CONSTRUCTION ACTIVITIES WITHIN THE LIMITS AND ADJACENT AREA, INCLUDING ANY NECESSARY CLEARING AND GRUBBING ACTIVITIES. THE CONSTRUCTION FENCE AND PERIMETER FILTER FABRIC FENCE SHALL BE MAINTAINED BY THE CONTRACTOR THROUGHOUT PROJECT CONSTRUCTION AND SHALL BE REMOVED BY THE CONTRACTOR UPON PROJECT COMPLETION.

UNDER NO CIRCUMSTANCES SHALL THE CONTRACTOR STORE EQUIPMENT AND/OR MATERIALS WITHIN WETLAND AREAS.
