Objective

The objective of this contract is to assist local governments with engineering and design tasks for certain ODOT-funded pedestrian and bikeway projects.

Major Tasks

Main tasks for this contract will be to support awarded Safe Routes to School projects or select Transportation Alternatives program projects with all phases of project development from PE through Stage 3 Design.

Other Tasks

The consultant may be required to perform miscellaneous tasks associated with engineering and design tasks for bikeway and pedestrian facility projects, such as updating or development project concepts, developing certified cost estimates, and providing technical assistance on studies, data analysis, feasibility studies, and mapping.
