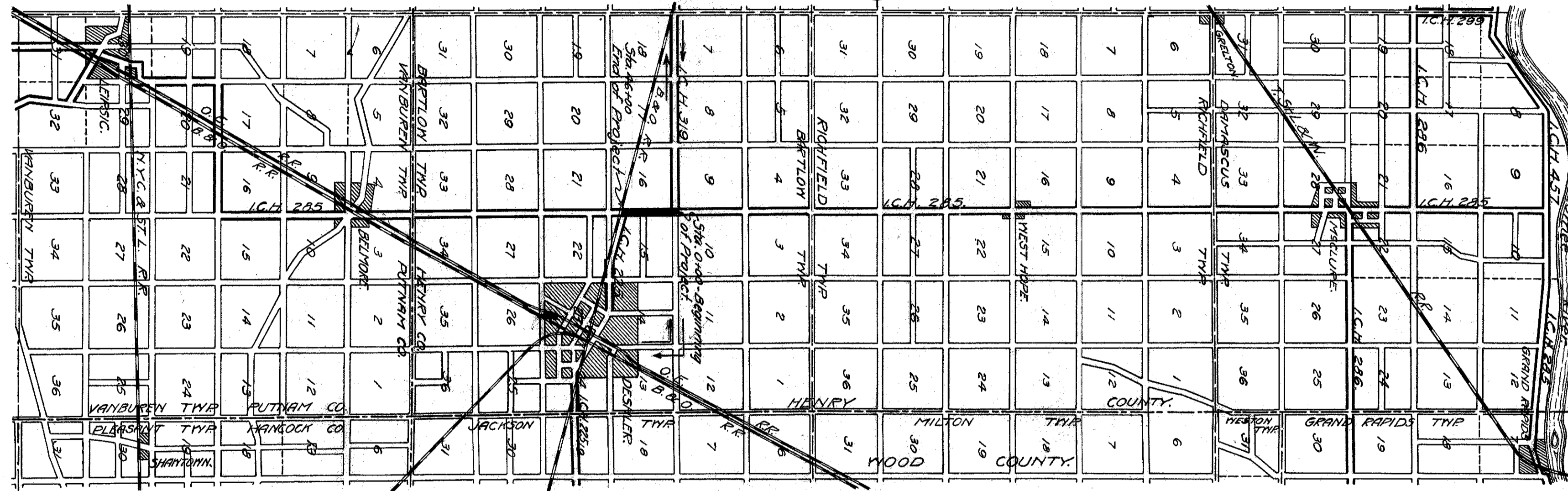

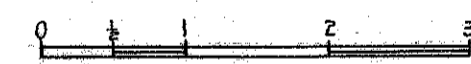

Sta 0+00 Beginning of Improvement



Sta 0+00 Corner stone at northwest corner Section 15. Head spike in 12" elm 44.7' N.W. Gas pipe 42' S.W.

Sta 4+86 Place 20-12" Corrugated Pipe 21' left of E with 2 Standard 12" Headwalls.

Sta 26+339 Corner stone at west quarter post Section 15. Gas pipe 32' N.W. Gas pipe 32' S.W.

Sta. 0+18 Remove 36 lin. ft 22" V.P. Build 30" Cast Iron Pipe culvert as shown on bridge and culvert plans. Length 46 feet.

Sta. 8+00 Build Standard 16" Cast Iron Pipe culvert 42'-0" long with Standard 16" Headwall on each end.

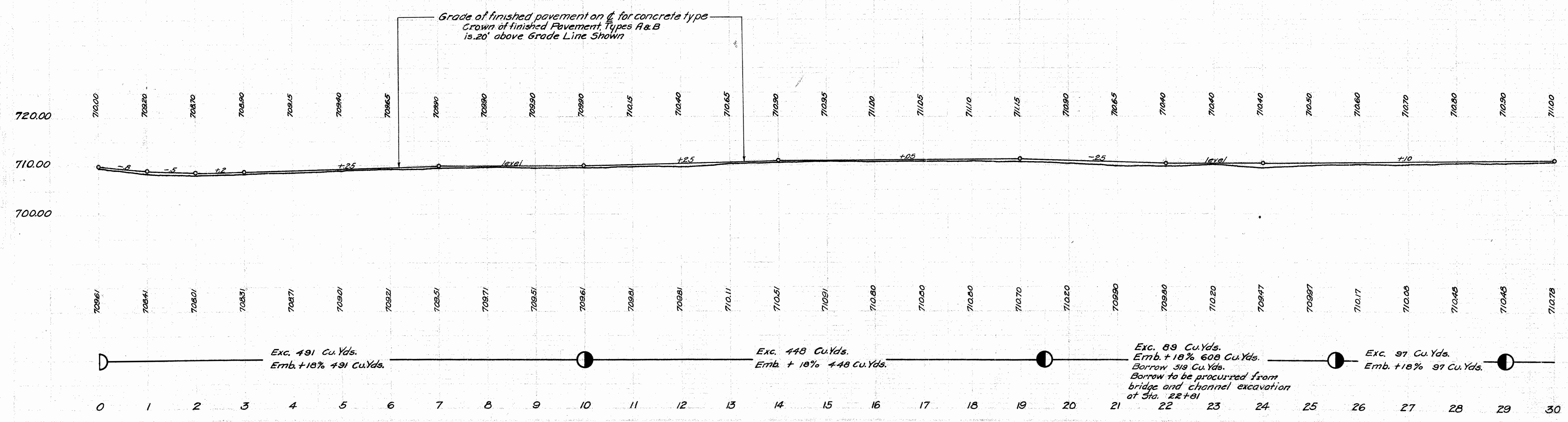
Sta. 22+81 Present Structure, 16" steel bridge 27'-0" opening. New Structure, Standard 40' x 20' Concrete Girder bridge

Sta. 26+50. Build Standard 12" Cast Iron pipe culvert 40'-0" long with No. 2 C.B. on left and Standard 12" headwall on right. Remove 30 lin. ft. old 6" V.P.

B.M. on spike in 12" elm about 45' NW. of 0+00 Elevation 709.20

B.M. on spike in 10" white ash 125' west of Sta. 13+15 Elevation 709.58

B.M. on spike in 10" white ash 30' west of Sta. 25+55 Elevation 709.17
