June 9, 1927 Commissioners offered compensation (Vol. 53, Pg. 878) which was accepted by Wright and Hull. Commissioner's passed resolution to deposit balance in Probate Court (Vol. 54, Pg. 1195) and M.E. Puhl and P.M. Puhl withdrew from Case. On an agreed verdict commissioners gave Weaver, Perrin and McGovern a quit claim deed to all rights in property appropriated, retaining the right for lateral support of fill only.
