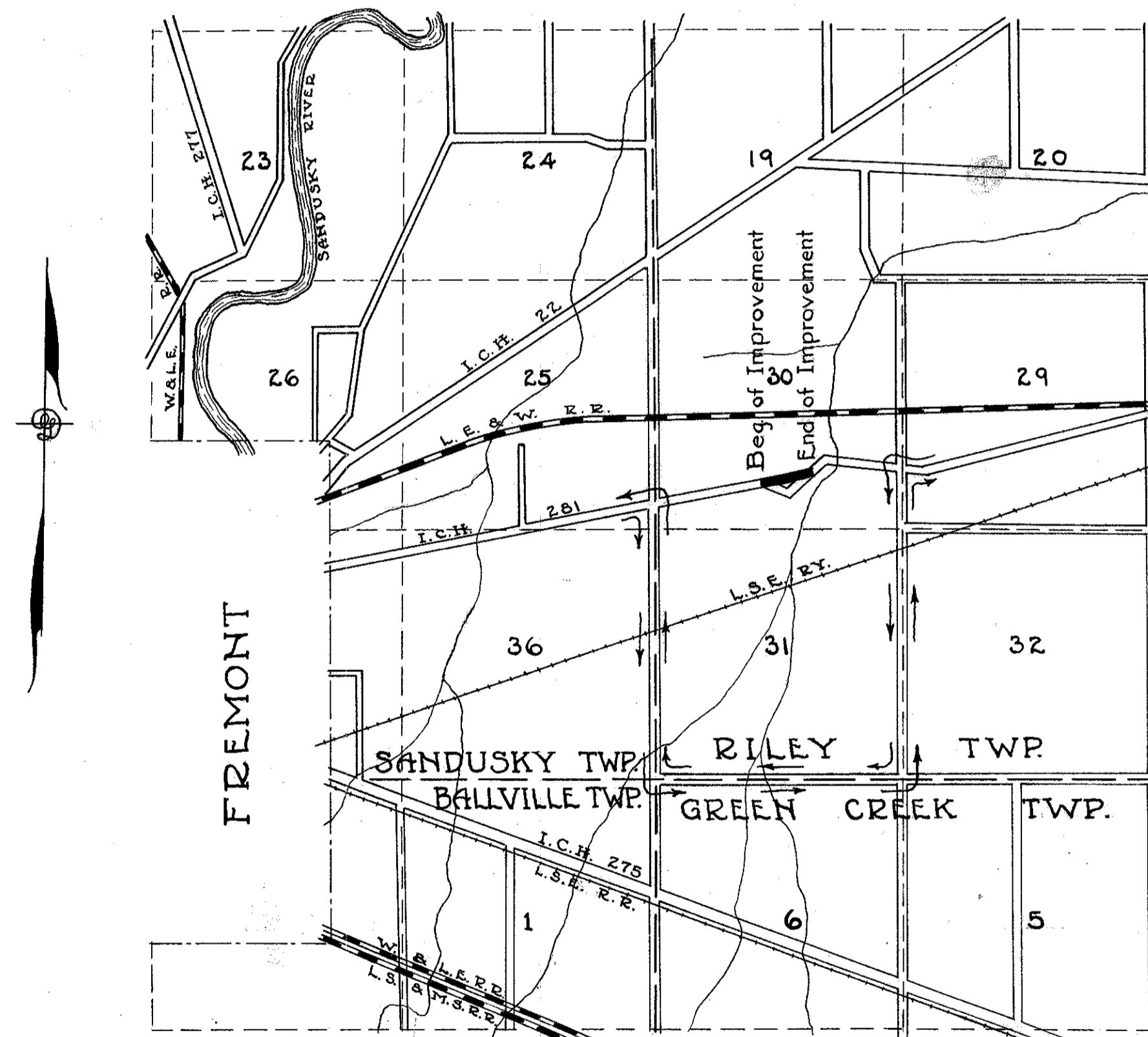

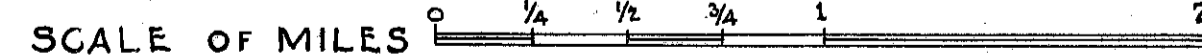

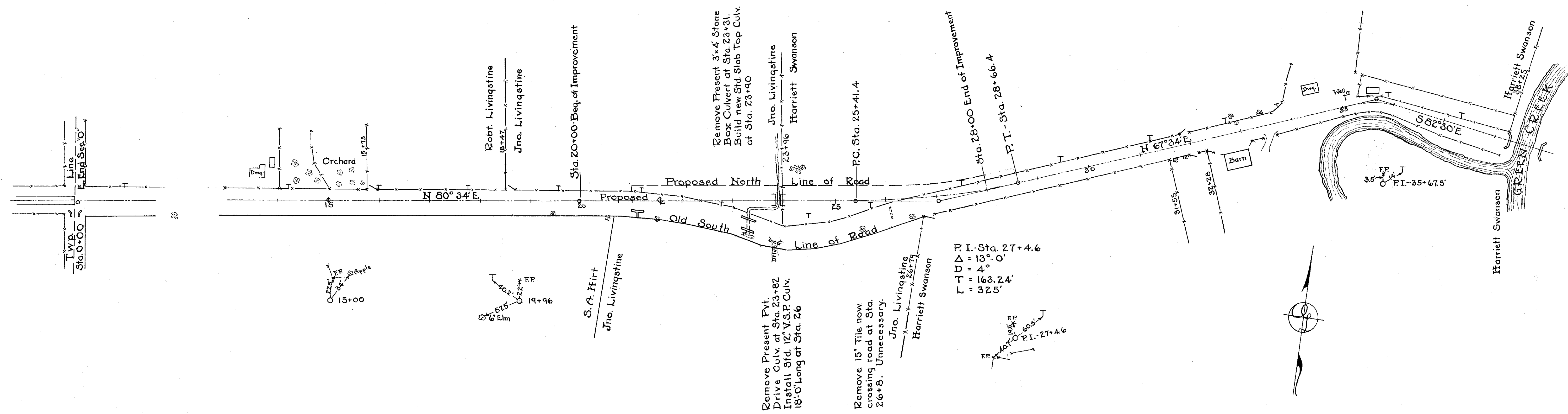
LOCATION MAP

 Cross Sections 1"=5' Profile (Horiz.) 1"=100'

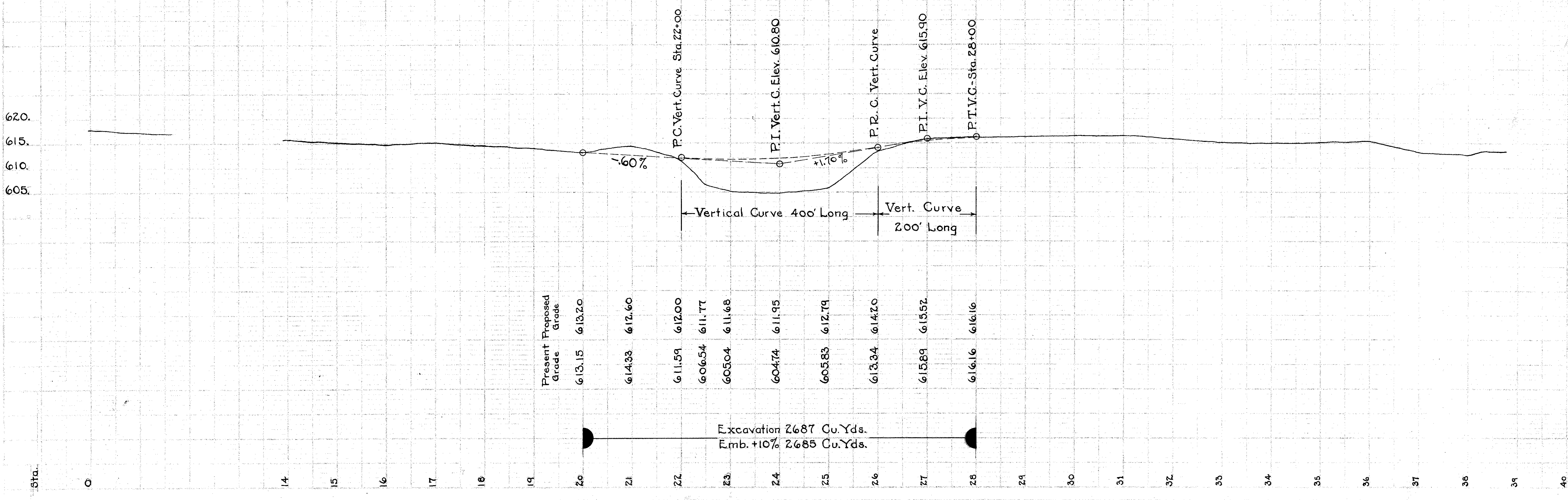
