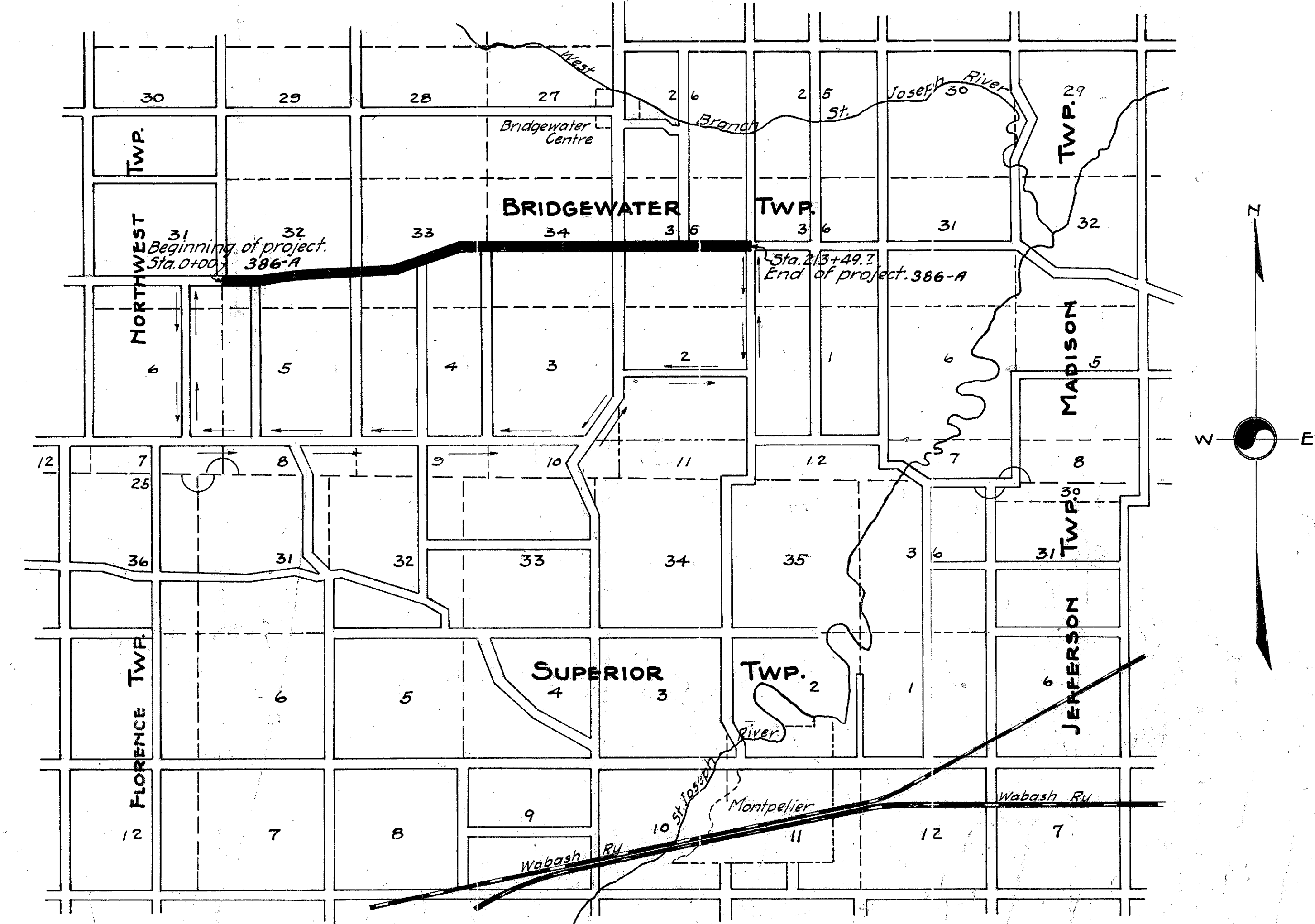

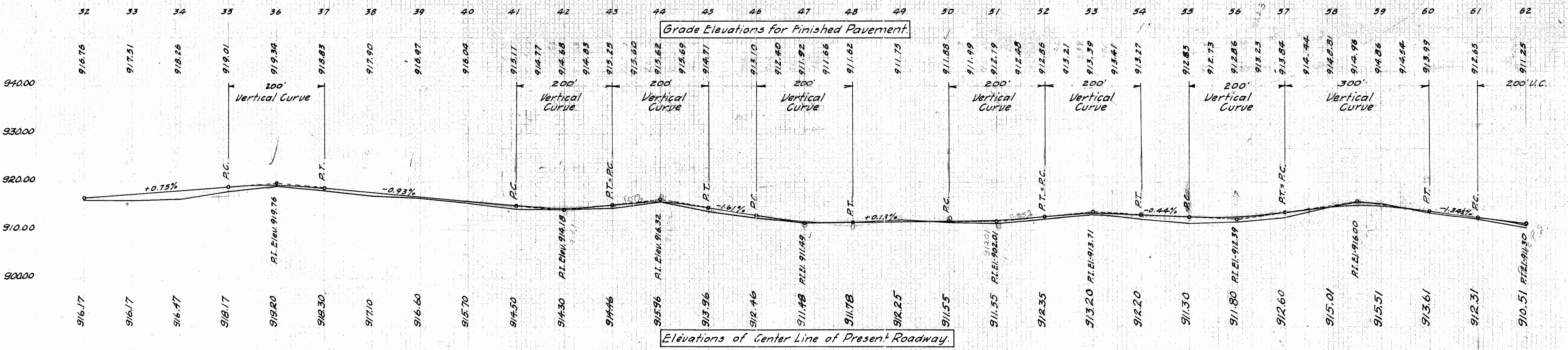


B.M. Sta. 35+90 Spike in 26' Elm to South Elev. 920.93

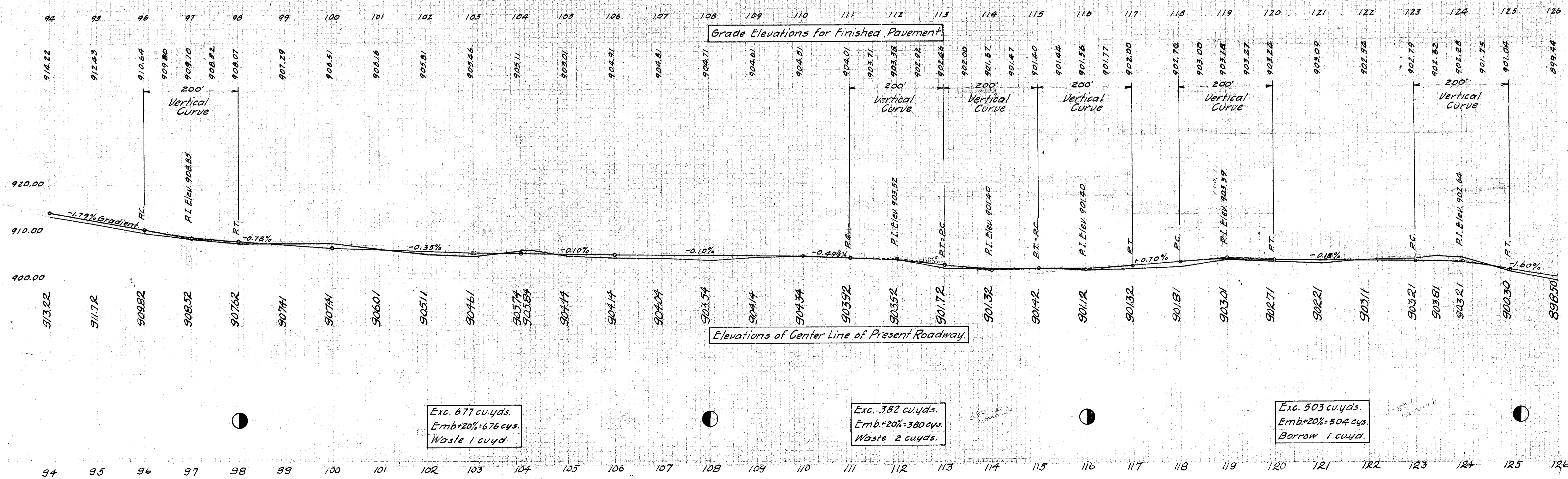


B.M. Spike in West one of row of Maples, El. - 914.11. Sta. 94+

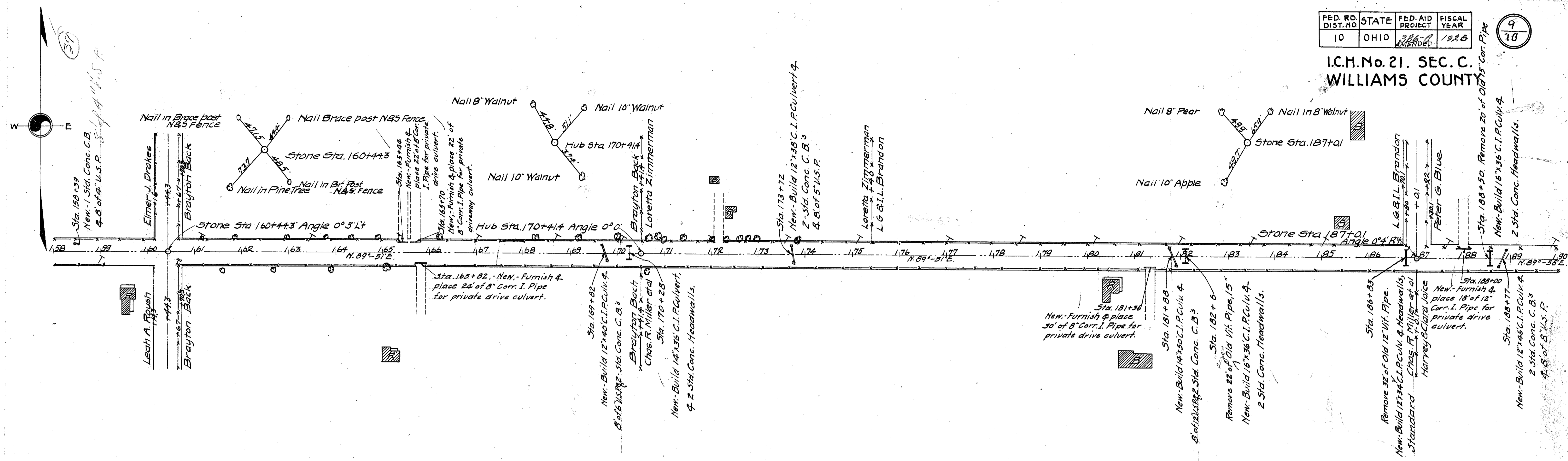

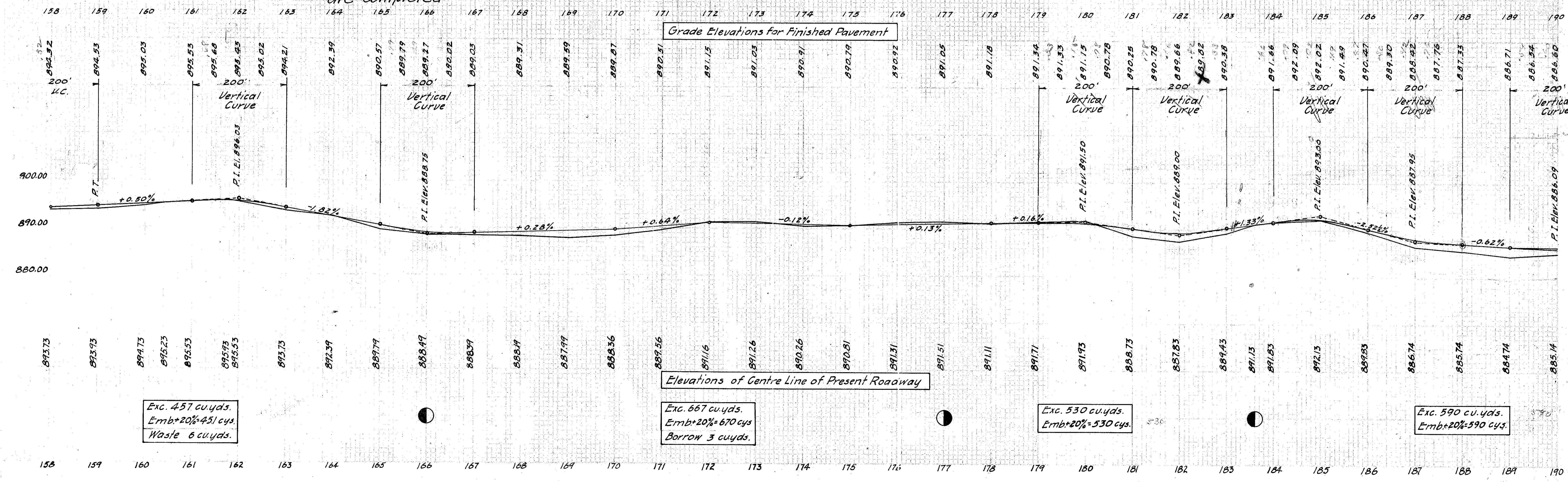

Elevations of Centre Line of Present Roadway



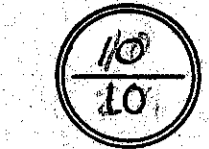

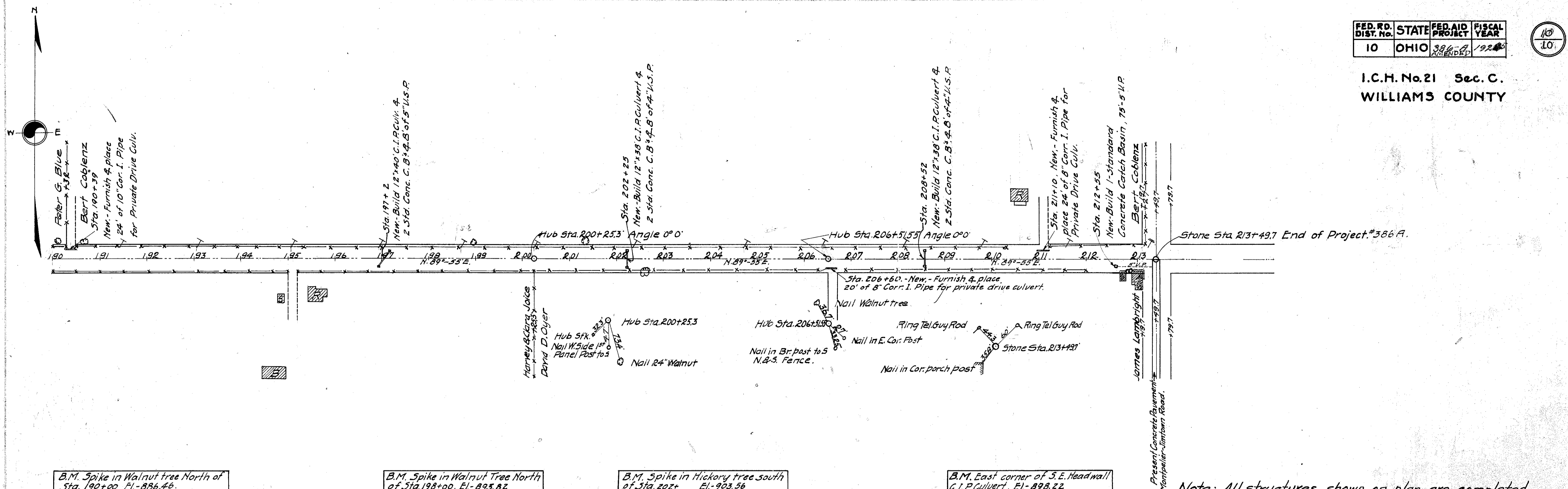
