





QUITCLAIM DEED

KNOW ALL MEN BY THESE PRESENTS: That the State of Ohio acquired perpetual easements, warranty deeds, channel agreements, sewer agreements over the hereinafter described lands, and which are recorded in the Record of Deeds in Wood County, Ohio, and

WHEREAS, the State of Ohio and the Maumee Watershed Conservancy District on the 13th day of April 1961 entered into an agreement, designated as Ohio Department of Highways Agreement No. 813 and Supplemental Agreement Nos. 813-A and 813-B, providing for the construction of a Diversion Channel to divert water from the existing Grassy Creek for the alleviation of floods in the City of Perrysburg and vicinity, and

WHEREAS, the State of Ohio, Department of Highways, has completed the work and by Resolution No. 191 and No. 217, the Maumee Watershed Conservancy District has reported that all work was found to be in satisfactory condition and to be in accordance with the construction contract plans and specifications, and

WHEREAS, I, P. E. Masheter, Director of Highways have determined that the Department no longer needs to retain said property for State highway purposes, and said determination appears in Volume 52, Page 456, in the Right-of-Way Section of the Journal of the Director of Highways, and

WHEREAS, the Maumee Watershed Conservancy District, have determined the lands as needed and economically desirable for the operation and maintenance of the Grassy Creek Diversion Channel;

NOW THEREFORE, the State of Ohio, by P. E. Masheter, Director of Highways, pursuant to Section 5501.162 of the Revised Code of Ohio, for and in consideration of the agreement to reimourse the State of

Ohio TWO HUNDRED FORTY EIGHT THOUSAND THREE HUNDRED FORTY NINE AND NINETY FOUR HUNDREDTHS (\$248,349.94) DOLLARS by the Maumee Watershed Conservancy District, does hereby release and forever quitclaim unto the said Maumee Watershed Conservancy District, all rights, title and interest the State of Ohio may have in and over the following described real estate:

PROJECT WOO-475-0.09

From the Maumee River to State Route No. 65.

Parcel No. 1-Y (Channel Agreement), and 1-SL (Slope Agreement), recorded in the Wood County Clerk of Courts Journal under Case Number 37195.

PARCEL NO. 1-Y (CHANNEL)
THE RIGHT TO CONSTRUCT AND MAINTAIN A CHANNEL

Being a strip of land 120 feet in width, same being 60 feet in width on each side of the following described centerline, located in River Tract No. 60 and north of State Route No. 65 in Perrysburg Township, Wood County, Ohio.

Beginning at a point of intersection in the centerline of State Route No. 65, with the easterly line of said River Tract No. 60; thence South 65 degrees 36 minutes 45 seconds West, along said centerline of State Route No. 65, a distance of 16.10 feet to a point; thence South 74 degrees 51 minutes 45 seconds West, along said centerline of State Route No. 65, a distance of 568.88 feet to the true point of beginning; thence North 12 degrees 51 minutes 45 seconds East, a distance of 234.29 feet to a point; thence northwesterly with a curve to the left having a radius of 200 feet and an arc length of 141.05 feet to a point; thence North 27 degrees 32 minutes 40 seconds West, a distance of 397.19 feet to a point; thence North 24 degrees 08 minutes 30 seconds West, a distance of 178.28 feet to a point; thence northwesterly with a curve to the right having a radius of 200 feet and an arc length of 44.24 feet to a point; thence North 11 degrees 28 minutes 00 seconds West, a distance of 594.69 feet to a point; thence North 23 degrees 38 minutes 00 seconds West, a distance of 44.09 feet to the South bank of the Maumee River and there terminate.

In addition to the above described strip of land the following described parcel, also being in River Tract No. 60 and North of said State Route No. 65, and immediately West of said 120 foot strip, more particularly described as follows:

Being a strip of land 120 feet in width, same being 60 feet in width on each side of the following described centerline, located in River Tract No.60 and south of State Route No.65 in Perrysburg Township, Wood County, Ohio.

Beginning at a point of intersection in the centerline of State Route No.65 with the easterly line of said River Tract No.60; thence south 65 degrees 36 minutes 45 seconds west, along said centerline of State Route No.65, a distance of 16.10 feet to a
