I found out from our asbestos trainer, the building on PCL 001 does not have to be removed by an asbestos company. Since the tiles are adhered to the cement and the plan is to demo the building in its entirety, ODOT can remove the structure. Debris must go to landfill accepting asbestos materials, they informed me most do if not disturbed. The Demo form must be sent in with payment 10 days prior to demolition.
