And thanks for checking your calendar and Doug's. Is he with ODOT? I will start including him on communications regarding this case if he is.

In response to your specific questions:

- Do you need an appraisal update/upgrade (do you want a C-SUM or is the VF OK for trial)? If we are headed for trial, we will need a full (before and after) summary appraisal. A VF is not allowed for trials. I typically try to settle the case through informal negotiations before I ask the district to spend the money for a full appraisal. I will keep you updated on that. What is your turn around time if a full appraisal is needed?
- Can you provide Owner's Appraisal when available? I will definitely provide you with their appraisal, once I receive it. We are at the initial stages of this case and neither party has filed for discovery yet.
- Do we need to schedule a Mediation (requested with Answer)? When I reach out to opposing counsel to discuss, I will ask about mediation. I don't think we are quite to that point yet, but will update you as we go.
- Have we received any further demands to reach a settlement? We have not received any further demands for settlement. I will let you know if they provide any counter offers.

In short, this case is just getting going. I will keep you updated throughout the process.

AAG Justine Allen is assigned to Parcel 2. I suspect her responses to your questions are the same as mine for Parcel 1. We will work together to keep you updated.
