Hi Kimber,

Yes, the attached work agreement is approved (for ODOT use). I do not know if opposing counsel 'approved,' but we do not need their approval for ODOT. I do not have a great exhibit, so I proposed a combination of all the attached; however, one created in the field (like a plan sheet with sketches, etc.) may be better. The exhibit simply should allow for ODOT to be on the property as needed and show the work area. The owner will likely want more details as ODOT is currently proposing to go anywhere on their property to fix the drainage (rather broad).

I believe we can accept Chris Walsh signature for the work agreement. The Operating Agreement allows for any member **or manager** to act solely on binding the LLC company. As long as Chris holds himself out as a manager for Act; we would be fine. Also, their attorney provided the name for representing the LLC at this field meeting; so I am confident that it would be acceptable.

We will work on PCL 1 and get you the responses on 6/23 as requested. Thanks for explaining the details of your expectations.

Attached is the Work Agreement form. I also attached the word doc incase you need to make any alterations. I have attached a number of exhibits to document the parcel location as we do not have a 'plan sheet' that covers this work. The attached email also explains the field tile work that can be done to help with the water situation. We greatly appreciate you getting this approved by and signed by the owner's representative.

We hope to have an in-person meeting with ODOT, contractor, Fairfield County (water and soil), and the owner. We think this Thursday afternoon the 23<sup>rd</sup> is the best date as storms are expected tomorrow. Can you facilitate getting a representative of the owner to join us? What time on Thursday afternoon works well (noon to 4 ideally)?

The meeting will explain the details of the suspected location of the drain tile issue and discuss the methods to address it. Although some trees will likely be affected; we do not plan to remove all. We would like to start this work ASAP (Thursday when in the field would be a great start).

Hi Justine,

I hope you are well. I also left you a VM regarding the same.

For PCL 2 (ACT); our construction section needs to get on the drainage issue ASAP. Kimber informed us all that ACT is 'accepting' of ODOT fixing what we need to fix which may help their overall drainage on the property (but maybe not) by correcting some field tiles that appear to be failing. This work is in addition to the agreed settlement amount of \$59,000.

Our crews need to have the contact information to go over the details with owner. Can you provide the contact information of the attorney to work through; or if allowed, the owner direct contact (we have that in file, really just need to know who they are permitted to discuss with)?

Second, does the settlement entry include the approval to do this work or should ODOT staff obtain a right to enter (either a right of entry or a Work Agreement)? If needed, can Kimber seek that directly through owner or does that still need to funnel through AGO/Attorney?

ODOT construction needs to resolve this issue by end of this week to avoid potential delay claims.

Corinna: if Justine is out for an extended period; can you help us with these issues?

Good afternoon Corinna, Justine and JR:

There has been a development on a culvert being replaced in the ROW on ACT's property. The video is most descriptive as it shows the water being pumped out of the hole all the while water keeps rushing in. Soil and Water believes this is due to crushed, broken or missing field tile in Act's field.

Due to the project work at the roadside, ODOT needs to have this repaired before our project can go forward. Per construction and project manager, ODOT is willing to repair this problem for ACT. Could be the reason his field continues to flood and fix a hurdle he has come up to at development of the field.

Wanted to know how to proceed as our construction team would like to complete the repair in the next week if possible to keep the project on time. Is there a way for us to contact ACT and put forth the request for a Right of Entry to repair this issue? This field tile actually ties in to other field tiles which feed into a natural river at the south boundary of the property.

Please advise how best to move forward? The fix would be completed at no cost to Act.

Justin / Doug,

Shelly Co dug down and found the clay tile on the south side of 256. When they uncovered the line, a great deal of water with a lot of pressure was flowing back through (coming north) the clay tile (see photos and video). The field on the south side of SR 256 is mostly under water.

Shelly Co had 2 pumps running for about 2 hours trying to dewater this hole but were unable to ever get the water to stop flowing.

Shelly co backfilled the pipe for the time being until we can figure something out, especially with more rain coming.

Do you guys have any thoughts or ideas on what to do here? It seems like the clay tile is possible broken somewhere in the field, but without getting this ditch to dry up some, I'm not sure how we're going to construct these pipes or the widening / filling in the ditch.

The subject culvert is inventoried as an 18" x 40' corrugated metal pipe. I was incorrect on its current rating, it is rated a GA=6 (satisfactory). If you feel the best decision is to replace, please proceed accordingly. Please check with Doug on the designers principles when keeping the culvert separate from the deeper tile system. A 2<sup>nd</sup> possible reason for this could be that debris may be less apt to get into the actal tile by keeping the culvert higher and separated.
