Hello Kimber,

I called Peggy Hutchison and answered her questions.

I called Peggy back at 1-740-503-0957. She shared that a gentleman crashed through her fence, into the tree, and passed away on 11/12/20. Her husband and her decided to check with ODOT to see if they should spend money to fix the fence since they recently got an intro letter from ODOT and they had heard about the turn lane project. They did not know if the fence would need removed for the project. I informed her that the encroaching fence would need removed for the project and it would not be advantageous to fix it at this time. She asked if the turn lane would be long enough to reach her house. I explained the plan sheet without the benefit of her seeing it and her reaction was that the road and ROW would be on her house (it will be about 11 feet from R/W) and she is concerned about the safety of living that close to the road. I also explained that the trees would be removed too. I also explained the utility poles and lines would be relocated closer as well. I provided them your name Kimber and your phone number. I informed her that you will contact them in the future for the acquisition but I did not know if that would be before or after the Holidays (maybe into January or February). I did go over their basic rights that include not being required to accept the ODOT offer, rights to appropriation, and that they can have attorney representation if they so choose. I also explained that her parcel is zoned Commercial when she mentioned that nobody will want to live in a home so close to the busy road. She was thankful for the information and shared that her husband is in quarantine because she just had Corona. I told her that we can mail the offer or meet in person or send it electronically. Peggy was very understanding of our needs and seemed willing to work with us.
