That is fine ... we would like something signed by owner indicating their intentions to NOT also be communicated with. We will of course work with Attorney and not 'negotiate' the parcel outside of representation. See P&P 5202.09:

5202.09 Negotiating With a Party Representing the Owner

An owner may nominate another to represent them in negotiations. Before a negotiator deals with any owner representative, the negotiator must request the owner provide written notice to the negotiator identifying the owner's representative as their nominee in these negotiations.

If the representative is the owner's attorney, the negotiator may accept a letter from the attorney stating the attorney is representing the owner. The negotiator should also verify this information, in writing if possible, with the owner.

We would like to get something from owner indicating that ODOT is to 'exclusively' work with Attorney Kenter and NOT deal directly with owner in any capacity (including and especially the relocation). Usually, attorneys will permit our relocation agent to work with owner directly on relocation, but that needs confirmed with owner and attorney. We want to treat the owner correctly and that includes the adversary services with owner for relocation (all that can go through attorney if owner insists).

Thanks for confirming with owner via Attorney Kenter. Thank you.
