- PCL 9-10-11-12 PDF in REAL OS appears to be missing the portions of construction plans at Stage 2 provided to owner(s). Please add them to file. If not provided, please provide at closing, and add to file.
- FYI: D5 would like to see more thorough notes. For EX: Parcel 9 does not appear to address concerns related to drainage and staking. I assume the drainage maintenance question was answered and resolved (because they signed later). I do have email evidence that we staked, but notes do not address that communication of staking getting done or any other follow-up.
