## WARRANTY DEED

KNOW ALL MEN BY THESE PRESENTS; That JUDY J. FABER, an unremarried widow, of Perry County, Ohio, for valuable consideration paid, grants, with general warranty covenants, to PERRY COUNTY DEVELOPMENT CORPORATION, LLC, whose tax mailing address is 2525 Panther Drive, New Lexington, OH 43764, the following real property:

## **PARCEL ONE:**

Situated in the State of Ohio, County of Perry, Township of Pike, T-15, R-15, being a part of Eleanor Mechling ET AL, OR 69 Pg. 827, being part of the Southeast Quarter of Section 4, and more particularly described as follows:


