

Scott, DPS, and DPU,

ODOT Office of Hydraulics is recommending barrier inlets be used with the 81" barrier instead of windows. They believe the 4" window in combination with the flat slope through the opening may be problematic with debris, snow, and ice. The inlet design will follow the existing ODOT Standard Construction Drawing I-3D: <u>I-3D_2022-07-15.pdf (state.oh.us)</u>. OHE is modifying this drawing to reflect the 81" design and should have this done by the end of the month.

There are a few locations on the FRA-161 Noise Wall project that will not allow for the inlet design due to shallow ditches. These will retain the windows but the window height will be increased from 4" to 6". These locations are not in the sumps and have a good profile to keep debris collection to a minimum. The tied block mat behind the window will remain. These were placed based on hydraulic calculations; additional windows were added based on Stage 2 feedback as well. Arcadis is working through the Stage 2 comments and will provide a disposition at the Stage 3 submittal, which is scheduled for Monday, 3/25. The new inlet details will not be available in the set as of Monday, but I will send the modified plan sheets as soon as they are done.

Long term, OHE will have hydraulic modeling performed to evaluate the window option and to optimize the design to accommodate hydraulics and debris.

Please forward to the staff responsible for maintaining these inlets to ensure this is acceptable.
