March 4th 1868

Be it known that on this fourth day of March A. D. 1868, The Commissioners of Franklin County Ohio appointed Isaac Spindler, John Townsend, and O. P. Hines, and W. P. Brown Surveyor to view and survey said road in accordance with the petition, and that said viewers and surveyor meet at William Baird on the Columbus and Winchester Turnpike in Madison Township on Saturday the 14th day of March A. D. 1868 at 10 O'Clock A. M. and make their report in writing in accordance with the law in such case made and provided.

To the Commissioners of Franklin County State of Ohio, Greeting,

We the undersigned petitioners do hereby most vehemently object to the vacating of any part of the County Road established in the petition of Jacob Miller and others, which has been a public highway for many years, which said Road Commences at the northwest corner of Section No. 16 Township 11 In Range 21 and Running Thence north on the Section between Section 8&9 to the Columbus and Winchester Turnpike, a part of which said County road John M. Guffey and others have filed a petition before you to vacate, said vacation to Commence at the N. W. Corner of the S. P. Brown the Surveyor proceeded to the discharge of the duties of their appointment, that they fixed, as the initial point of said road, a stone at the South West Corner of the South east quarter of Section 16 Tp. 11 R. 21 Congress Lands, starting thence laid out said road and caused the same to be surveyed along the following described route. 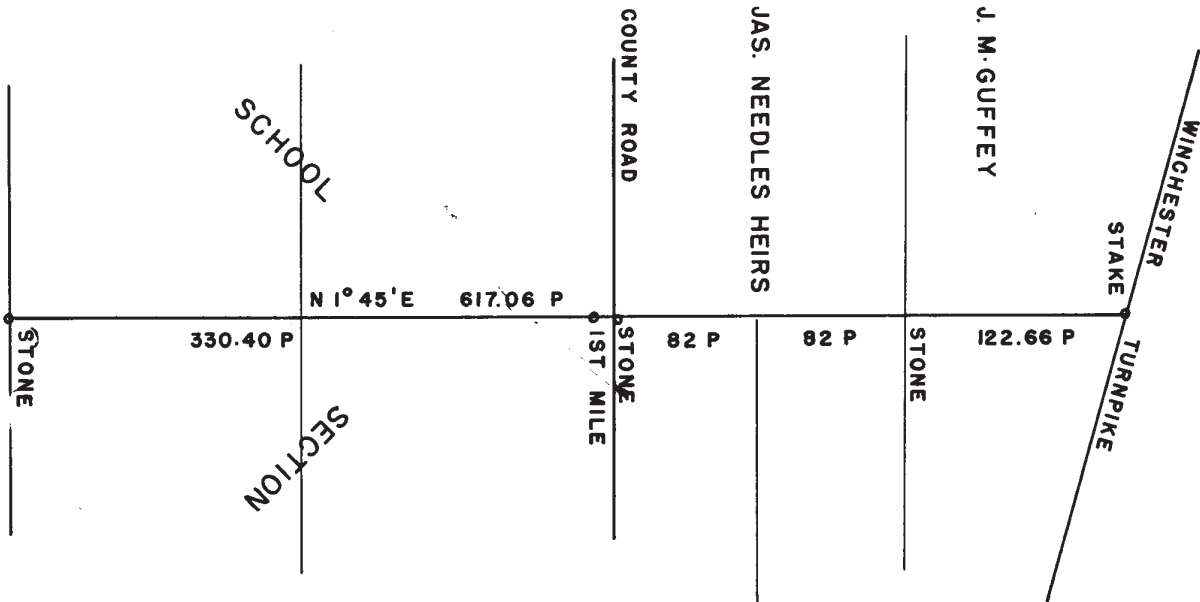

Guffey said road is hereby established in accordance with the law in such cases made and provided.

And afterwards to wit; on the ninth day of September A. D. 1868 came the said John M. Guffey by Wm. Baird and paid into the County Treasury the sum of fifty five dollars the amount of damages and compensation assessed against them in obedience to the order establishing said road.
