Thanks for passing this along...Some comments to note:

- a) The new Vine St. roadway mill/fill line is within 25' from the centerline of track, and so from strictly a safety standpoint, an ODOT/NS Letter Agreement from my shop is recommended... MH response noted
- b) If the proposed sidewalk at the NE corner (which I'm assuming will be concrete) is located as proposed, NS may take issue w/the end of the sidewalk being approx. 8' from centerline of track they usually won't accept concrete this close to the track, but should be OK w/asphalt for ease of track maintenance equipment & replacement as needed. I'd also recommend bringing the 'End Mill and Fill Vine St.' roadway line across and have the new sidewalk match up w/that line... MH response the limits of proposed concrete sidewalk match the limits of existing concrete walk and are outside the 8' measured from CL of track
- c) I don't have any comments on the 'Right-of-Way Needs' section of M&H's Designer Notes MH response noted
- d) "Norfolk Southern" should be shown to ID the tracks somewhere on the plans MH response will add for next submission
- e) "AARDOT #524743Y" should be shown at the centerline of Vine St. and the NS tracks MH response will add for next submission

Once Stage 1 plans are completed and passed onto me, I will then forward a Letter Agreement to NS...
