On Wednesday 5-3-2000, our safety review team met concerning these intersections. They have decided that this project warrants further detailed investigations to determine the most reasonable and economical improvement for this section of highway. We will be authorizing Woolpert Consultants to perform a preliminary engineering report for these intersections. I will continue to keep you informed as this progresses.

RE: Intersection of US 50 and SR 134

Dear Representative Stapleton:

Thank you for giving us this opportunity to discuss our studies of the intersections of US 50 and SR 134.

This is an offset intersection located within the unincorporated named community of Dodsonville. The south leg of SR 134 being located just east of a crest vertical curve, with the north leg of SR 134 located approximately 370 feet to the east. The south leg of SR 134's intersection with US 50 has the greatest sight distance restriction. Already present at these intersections are side road warning signs located in advance of them on US 50. The south leg of SR 134 also has overhead flashers to warn the motorists on US 50 of this intersection's presence. Another noteworthy safety measure present at this location, is the 45 MPH speed zone that starts 0.33 miles to the west of the south leg of SR 134, and ends 0.21 miles east of the north leg of SR 134.

Preliminary studies resulting from the centerline survey that was performed has determined to correct the intersection sight distance problems will require that the profile of US 50 be corrected. This will require lowering US 50 west of the south leg of SR 134 and raising it to the east side. Performing this work would affect up to two residences, a business, a church that possibly is historical, and a township building that could be historical. Presently it is estimated the cost of performing this work is approaching \$ 250,000.

Another possible improvement that we are investigating involves moving the south leg of SR 134 further to the west. To perform this work would require buying the right-of-way, and would affect a business and a residence. To correct the sight distance problems associated with the north leg of SR 134 would still require lowering the grade of US 50. Present estimates to perform this work is \$ 400,000.

Our investigations have found that in four years we have had six accidents recorded at this site. The accident rate at this location has not flagged this location as a problem area. But because of the intersection sight distance problems at this location, we have added this to the locations that our Highway Safety Review Team studies for improvements.


