I am writing to you for two reasons. First to thank you for taking the time and effort out of your busy schedule to come to Highland County to help promote the passage of our levy. The planning and coordination by your staff was outstanding. I believe the rally gave a big boost to the campaign. Secondly, I am asking at this time if you could help us in an additional way.

As we have attempted to communicate to our district voters about this outstanding opportunity for our children and community a question keeps coming up about a certain traffic intersection that is located approximately one quarter mile from the site for our new buildings. Many of our buses, student drivers, and staff members will have to negotiate this intersection each day in getting to and from school. Even though it has a yellow flashing caution light, the intersection still poses a safety risk because of a blind spot and the heavy truck traffic on the highway.

The intersection is located at State Route 50 and State Route 134.

*Does Not Meet Warrant*

Any help your office could provide in getting ODOT to look at this intersection and consider either eliminating the blind spot or putting in a stop light would be greatly appreciated. It would also help alleviate the aforementioned concern that has been expressed to us on several occasions.
