ENGINE BRAKING

JACKSON COUNTY ENGINEER BRIAN MCPHERSON DISCUSSED THE REQUEST OF THE ENGINE BRAKING AT BERLIN CROSS ROADS. THE RESIDENTS IN THE AREA HAS SUBMITTED A PETITION TO THE COMMISSIONERS REQUESTING TO HAVE NO ENGINE BRAKE SIGNS ON STATE ROUTE 327 AND FAIRGREENS ROAD. ENGINEER BRIAN MCPHERSON SAID FOR THE ACTION TO TAKE PLACE THE COUNTY COMMISSIONERS HAVE TO PASS A RESOLUTION TO SPECIFIC ITEMS IN THE RESOLUTION HAS TO BE MADE TO OHIO DEPARTMENT OF TRANSPORTATION (ODOT) FOR THEM TO GIVE HIM THE OK TO ORDER THE SIGNS. THE COUNTY HAS TO PAY FOR THE SIGNS AND ODOT WILL PUT THEM UP. THE RESOLUTION IS AS FOLLOWS:

- THE RESOLUTION MUST STATE THAT THE ACTION IS BEING TAKEN BY AUTHORITY OF SECTIONS 505.17 (A) AND 4513.221 (E4) OF THE OHIO REVISED CODE
- 2. THE RESOLUTION MUST ALSO STATE THAT A REGULATION IS BEING ESTABLISHED TO PROHIBIT ENGINE BRAKING WHERE APPROPRIATE SIGNS (CONFORMING TO ODOT SPECS FOR STATE HIGHWAYS OR COUNTY SPECS FOR COUNTY HIGHWAYS) ARE ERECTED.
