Dear Mr. McConnell:

ODOT ("the Department") finds McConnell Contracting, Inc. ("McConnell") has demonstrated adequate GFEs in its documentation to support the requirements of Federal Regulations (49 CFR Part 26) and the Department's DBE program guidelines. Please refer to the Project Information page enclosed for specific contract and subcontractor details.

The Department's evaluation was based on the scope, intensity, and appropriateness of the contractor's documented efforts to actively and aggressively obtain DBE participation sufficient to meet the DBE contract goal.

McConnell provided GFEs indicating that the shortfall was due to a last-minute bid quote that increased the bid amount. Consequently, McConnell's Utilization Plan did not meet the expected standards.

The Department recognizes that last-minute bid quotes can impact the DBE goal. Based on the efforts demonstrated by McConnell, the Department concludes that this issue was not intentional but rather an oversight that was remedied by increasing the committed DBE amount already included in the Utilization Plan.
