<b>Describe the Current Conditions</b>	Rabbit Road between West Main Street and Mill Street (Ohio 151) is rapidly deteriorating because the road is continuously traveled by trucks involved in the Oil and Shale industry in Harrison County and the surrounding area. The asphalt on a large section of the road has completely crumbled. On another portion of the road an entire lane of travel is cracked beyond repair and is continuously breaking down.

**What specific oil & gas activities directly contributed to the deterioration of the proposed project?**

Trucks are unable to travel on Mill Street (Ohio 151) because of a railroad bridge/underpass that is too low and too narrow. The only route around the railroad bridge is on Rabbit Road. Therefore, this stretch or road is forced to handle high numbers of trucks from the Oil and Shale industry.

Included in this application is a letter from Mid-East Truck & Tractor Service confirming that their trucks travel Rabbit Road with oversized trucks because of the railroad bridge/underpass on Ohio 151.

The Township would like to mill and replace 3" of asphalt and patch particularly bad areas of Rabbit Road between West Main Street and Mill Street.

## Project Evaluation Information

**Explain how the project scope and various alternatives were assessed, as well as cost estimates, environmental impacts, and right-of-way impacts.** The Township worked with W.E. Quicksall and Associates, professional engineers, to address the damage being done to Rabbit Road by trucks associated with the Oil and Shale industry.

**What other solutions were considered for this project?** The portion of the road that has completely deteriorated must be milled, patched and new asphalt installed. Similar work could be completed on other portions of the road along with filling cracks.

**Why is the proposed project a priority to your municipality/county? Use project details to support your response.** Repair of Rabbit Road is vital to Green Township, the Village of Hopedale, and the Oil and Shale industry. Rabbit Road is a vital connector between West Main Street and Mill Street (Ohio 151). Vehicles that cannot travel on Mill Street (Ohio 151) must travel on Rabbit Road in order to access US 22. Rabbit Road is also traveled by school buses taking children to and from school.

**What are the forecasted impacts if this project is not awarded funding?** Without funding from ODOT, Rabbit Road will continue to deteriorate due to the truck traffic and will become hazardous for cars to travel.

**Describe Any Previous Roadway Work/Repairs Done in the Past Five (5) Years?** The Township has not been able to do anything more than fill pot holes and cracks in the last five years. At least ten years ago one of the Oil and Shale companies payed for asphalt to be placed on part of Rabbit Road. However, no milling was done and the asphalt soon became broken up.
