Please see the attached Complete 401 Notification regarding the SCI-823-0.00 Project (Ohio EPA ID No. 134161). Also attached are a draft public notice, public notice instruction sheet, and a list of newspapers. The draft public notice will just need the highlighted dates changed to the date of publication. This will need to be published by 8/10/14, in order to ensure a 45 day public comment period before the public hearing. If the public notice is published after this date, the hearing will need to be moved, which will delay the final action on the 401 application.

Also, feel free to double check my numbers for the impacts. The numbers in this public notice reflect the changes that were made by Brett to the USACE public notice. The perennial stream impacts also include the temporary impacts to the Scioto River (150 linear feet), which is why this is greater than the amount in the USACE public notice.

OEPA has provided the final draft 401 public notice for public hearing for SCI-823-0.00, PID 19415 (Portsmouth Bypass Phase 2 & 3) (see attached). District 9 will need to act on getting the 401 public notice in the local newspaper as soon as possible. **This will need to be published by August 10, 2014 in order to ensure a 45 day public comment period before the public hearing which is set for September 23, 2014.** If the public notice is published after this date, the hearing will need to be moved, which will delay the final action on the 401 application. If there are concerns with this timeframe contact us immediately.

This public notice will need to be published in the following paper for at least one day:

**1st important item:** Once the newspaper provides you or the District 9 PIO with the date that the notice will appear in the paper, you or the District 9 PIO will need to **go into the attached Word file and type in the date the Public Notice will appear** (top of each page - highlighted). Please send us back the version with the dates filled in as soon as you have the dates, so that we can forward to Shelby Gilbert at OEPA.

**2nd important item:** We will need to obtain a copy of the **actual, published 401 public notice**. It is important that if the paper doesn't send it to the district right away, then you may need to bug them until you get it. Once you obtain a copy, please e-mail us a PDF version (if possible) and we will forward that to OEPA so they can finalize the 401 WQC.

**3rd important item:** Please make sure that the newspaper bills District 9 and does not try to bill Central Office-Office of Contracts.
