OHDOTCEv02 WorkSpace Tools Installer

This OHDOTCEvo2 WorkSpace Tools Installer is a standalone resizable c# Windows Presentation Form application that is used to install the OHDOTCEvo2 Workspace Setup tool and the OHDOTCEvo2 Standards sync tool.

Please note that running this install does not setup up or configure any workspaces, it simply installs the tools. To actual set up a OHDOTCEvo2 workspace involves two additional steps. 1st running the OHDOTCEvo2_Workpace Setup tool to set up the workspace and 2nd running the sync tool that downloads the workspace files.

This document is intended to be a reference document to explain all the options and functionality that exist in this application. It is not a workflow or how to guide. Please see our walkthrough video <u>here</u>.

Software Requirements:

This application was developed using .NET Framework 4.6.2 in 64 bit windows 10.

Loading the Application:

Download the latest version of the installer from our CADD Standards Downloads page

This Application must be run as an administrator!

Application Operation:

This application can be run in the following modes.

- 1. Install Mode: Used to Initial install of the application
- 2. Modify Mode: Used to modify install settings/repair install.
- 3. Update Mode: Used to install updates to the installer (OHDOTCEvo2 Workspace Setup Tool & OHDOTCEvo2 Standard sync tool)
- 4. Uninstall Mode: used to Uninstall the OHDOTCEvo2 Workspace Tools.

The mode will automatically be selected using the following logic

- 1. If OHDOTCEvo2_WorkSpaceTools_Installer has not been installed yet (not listed in Windows Programs and Features), then the Install Mode will be used.
- 2. If OHDOTCEvo2_WorkSpaceTools_Installer has previously been installed (listed in Windows Programs and Features) AND the version is equal to the currently installed program, then the Modify Mode will be used.
- 3. If OHDOTCEvo2_WorkSpaceTools_Installer was previously been installed (listed in Windows Programs and Features) AND the version is greater than the currently installed program, then the Update Mode will be used.



- 4. If the application is selected to be uninstalled from the program and features dialog OR the /uninstall command line parameter is passed, then the Uninstall mode will be used.
- 5. If OHDOTCEvo2_WorkSpaceTools_Installer has previously been installed (listed in Windows Programs and Features) AND the version is less than (older) to the currently installed program, then application will not run.

Update Page:

This page is displayed when the application is launched in Update mode. Select Update to update this application.

If this application has previously been installed (listed in Windows Programs and Features) AND the version is greater than the currently installed program, then the Update Mode will be used.

Uninstall Page:



This page is displayed when the application is launched in Uninstall mode. Select Uninstall to uninstall this application.

If the application is selected to be uninstalled from the program and features dialog OR the /uninstall command line parameter is passed, then the Uninstall mode will be used.

Results Page:



This page is displayed after running either the Install Button, Modify Button, Update Button, or Uninstall Button. It will list the results of the process. if anything failed that line will be red.

This button will launch the

OHDOTCEvo2 WorkSpace Setup tool which is the next step in setting up the OHDOTCEvo2 workspace. It is only displayed if on the Install mode, Modify mode, or Update Mode. (it is recommended to launch this app from the start menu instead to insure the tool gets loaded with regular permissions and not the admin permissions which are required to run the installer.)

Install Button

- Creates install folder at specified install directory if it doesn't already exist.
- Creates OhioDOT-CADD Start menu folder is it doesn't already exist.
- Creates c:\ProgramData\OhioDOT\OHDOTCEvo2_WorkSpaceTools folder is it doesn't already exist.
- Adds all installation files to the install folder (this includes the Workspace Setup & Sync tools).



- Added shortcuts to launch the OHDOTCEvo2 WorkSpace Setup Tool and Sync Tool.
- Installs/updates OHDOTSymbols true type font.
- Adds registry keys to Software\OhioDOT\CADD\Connect\OHDOTCEvo2_WorkSpaceTools.

- Log file is saved/updated at C:\ProgramData\OhioDOT\OHDOTCEvo2_WorkSpaceTools\InstallLog.txt

Modify Button

Modify When this button is selected the following happens

- Creates install folder at specified install directory if it doesn't already exist.
- Creates OhioDOT-CADD Start menu folder is it doesn't already exist.
- Creates c:\ProgramData\OhioDOT\OHDOTCEvo2_WorkSpaceTools folder is it doesn't already exist.
- Adds all installation files to the install folder (this includes the WorkSpace Setup & Sync tools).
- Added shortcuts to launch the OHDOTCEvo2 WorkSpace Setup Tool and Sync Tool.
- Installs/updates OHDOTSymbols true type font.
- All Workspace SyncData directories are saved to C:\ProgramData\OhioDOT\OHDOTCEvo2_WorkSpaceTools\WorkSpacesSyncDataLocations.t xt.
- Log file is saved/updated at C:\ProgramData\OhioDOT\OHDOTCEvo2_WorkSpaceTools\InstallLog.txt

Update Button

Update When this button is selected the following happens

- If previous version was for AdminTools (before name change to WorkSpaceTools) then install folder and registry will be update for new name.
- Creates install folder at specified install directory if it doesn't already exist.
- Creates OhioDOT-CADD Start menu folder is it doesn't already exist.
- Creates c:\ProgramData\OhioDOT\OHDOTCEvo2_WorkSpaceTools folder is it doesn't already exist.
- Adds all installation files to the install folder (this includes the sync tool).
- Added shortcuts to launch the OHDOTCEvo2 WorkSpace Setup Tool and Sync Tool.
- Installs/updates OHDOTSymbols true type font.
- Log file is saved/updated at C:\ProgramData\OhioDOT\OHDOTCEvo2_WorkSpaceTools\InstallLog.txt

Uninstall Button

Uninstall When this button is selected the following happens



• Deletes the install folder

- Removes Start Menu items (if no other OHDOT programs installed then the OhioDOT-CADD start menu folder is removed)
- Deletes C:\ProgramData\OhioDOT\OHDOTCEvo2_WorkSpaceTools folder
- Removes registry key SOFTWARE\\OhioDOT\\CADD\\Connect\\OHDOTCEvo2_WorkSpaceTools
- Removes Uninstall registry key

Command Line Parameters

This section lists the available command line parameters that can be passed when starting the application to set different default values.

/BOOLAGREEMENT=[TRUE/FALSE] Must be set to true in order to install silently. (Default is TRUE).

/BOOLGAOPTIN=[TRUE/FALSE] Allows you to opt in or out of Usage Analytics. (Default is TRUE). No longer in use!

/INSTALLDIR=[DesiredLocation] Sets the install location (Default is "c:\Program Files (x86)\OhioDOT\ OHDOTCEvo2_WorkSpaceTools\")

Note that application can be run silently but only for the update mode and uninstall mode. To run the application in silent mode simply ass the /Silent command line parameter. If the application is already installed and needs to be updated then it will default to the update mode automatically. To uninstall the application pass the /uninstall command line parameter.

/SILENT Runs the executable silently

/UNINSTALL Runs the executable in uninstall mode
