PATCH AND SEAL THE SUBSTRUCTURE, PAINT AND SEAL THE SUPERSTRUCTURE OF THE CLI-71-0031 BRIDGE WHICH CARRIES DOSTER RD OVER I-71 AND THE CLI-71-0407 BRIDGE WHICH CARRIES SMTH RD OVER I-71.

PAINT THE STRUCTURAL STEEL OF THE CLI-134-1107 BRIDGE WHICH CARRIES SR 134 OVER COWAN CREEK AND CLE-727-0263 WHICH CARRIES SR 727 OVER STONELICK CREEK. PAINT THE STRUCTURAL STEEL PIER PILES OF THE CLE-50-0546 BRIDGE WHICH CARRIES US 50 OVER SUGAR CAMP RUN.
