**GENERAL SCOPE**

THE INSTALLATION OF ADA RAMPS, SIGNAGE, PAVEMENT MARKINGS, AND RECTANGULAR RAPID FLASHING BEACONS THAT WILL INVOLVE PLACEMENT IN AREAS WITH PEDESTRIAN AND VEHICULAR TRAFFIC.

THE CONTRACTOR WILL BE REQUIRED TO PROVIDE A CERTIFIED FLAGGER, SAFETY BARRIERS, DRUMS, AND/OR ROPING TO CORDON OFF WORK AREAS UNTIL WORK IS COMPLETE.

ONE-FOOT MINIMUM VERTICAL AND HORIZONTAL CLEARANCE MUST BE MAINTAINED BETWEEN DOMINION EAST OHIO'S (DEO) EXISTING PIPELINE(S) AND ALL OTHER IMPROVEMENTS. EXTREME CARE SHOULD BE TAKEN NOT TO HARM ANY DEO FACILITY (PIPELINES, ETC.) OR APPURTENANCE (PIPE COATING, TRACER WIRE, CATHODIC PROTECTION TEST STATION WIRES & DEVICES, VALVE BOXES, ETC.). DEO FACILITIES MUST BE PROTECTED WITH A TARP DURING BRIDGE CONSTRUCTION. THE CONTRACTOR WILL BE RESPONSIBLE AND LIABLE FOR ENSURING THAT ALL DEO EXISTING FACILITIES, ABOVE AND BELOW GROUND, REMAIN UNDAMAGED, ACCESSIBLE AND IN WORKING ORDER. THE STANDARD SPECIFICATIONS OF THE CITY OF CLEVELAND AND THE OHIO DEPARTMENT OF TRANSPORTATION CONSTRUCTION AND MATERIAL SPECIFICATIONS, JANUARY 1, 2019 EDITION SHALL GOVERN THIS PROJECT. THIS SHALL INCLUDE ANY CHANGES OR SUPPLEMENTAL SPECIFICATIONS. SHOULD A CONFLICT ARISE BETWEEN THESE OR OTHER PROJECT SPECIFICATIONS, THE OHIO DEPARTMENT OF TRANSPORTATION STANDARDS SHALL TAKE PRECEDENCE.

**CONSTRUCTION SCHEDULE**

THE CONTRACTOR SHALL PROVIDE TO THE CITY AND O.D.O.T. ENGINEER A COMPLETE WRITTEN CONSTRUCTION SCHEDULE AND PLAN SHOWING SITE PREPARATION, ADA RAMP AND SIDEWALK INSTALLATION, AND DATE OF INSTALLATION FOR SAME AT THE PRECONSTRUCTION MEETING. UPDATED SCHEDULES WILL BE PROVIDED WITH EVERY SUBMITTED PAYMENT INVOICE AFTER THE CONTRACT IS AWARDED.

**CONSTRUCTION NOISE**

ACTIVITIES AND LAND USE ADJACENT TO THIS PROJECT MAY BE AFFECTED BY CONSTRUCTION NOISE. IN ORDER TO MINIMIZE ANY ADVERSE CONSTRUCTION NOISE IMPACTS, WORK HOURS WILL BE RESTRICTED TO 7:00 AM TO 7:00 PM.

THE CONTRACTOR SHALL APPLY FOR A NOISE VARIANCE TO PERFORM NIGHT TIME WORK. IN THE EVENT A NOISE VARIANCE IS NOT GRANTED BY THE DIRECTOR OF SAFETY, WORK SHALL COMMENCE DURING DAYTIME HOURS AT NO ADDITIONAL COST. ANY ADDITIONAL MAINTENANCE OF TRAFFIC COST WILL BE INCLUDED IN THE LUMP SUM BID FOR ITEM 614 - MAINTAINING TRAFFIC, AS PER PLAN. NO SEPARATE PAYMENT WILL BE MADE.

DO NOT OPERATE AT ANY TIME ANY DEVICE IN SUCH A MANNER THAT THE NOISE CREATED SUBSTANTIALLY EXCEEDS THE NOISE CUSTOMARILY AND NECESSARILY ATTENDANT TO THE REASONABLE AND EFFICIENT PERFORMANCE OF SUCH EQUIPMENT. THE NOISE LEVEL RESULTING FROM CONSTRUCTION SHALL BE WITHIN THE LIMITS SPECIFIED IN OSHA REGULATIONS AND ALL LOCAL ORDINANCES.

**CONSTRUCTION NOTIFICATION**

THE CONTRACTOR WILL ADVISE THE PROJECT ENGINEER A MINIMUM OF FOURTEEN (14) DAYS PRIOR TO START OF CONSTRUCTION ACTIVITIES, LANE CLOSURE, AND ROAD CLOSURES. THE PROJECT ENGINEER WILL FORWARD THE INFORMATION TO THE STATE AND/OR CITY AND ANY OTHER LOCAL OFFICIALS RESPONSIBLE FOR PUBLIC NOTIFICATION.

**AS DIRECTED BY THE ENGINEER QUANTITIES**

THE CONTRACTOR SHALL NOT ORDER MATERIALS OR PERFORM WORK LISTED IN THE GENERAL SUMMARY FOR ITEMS DESIGNATED BY THE PLAN NOTE TO BE USED "AS DIRECTED BY THE ENGINEER" UNLESS AUTHORIZED BY THE ENGINEER IN WRITING. THE ACTUAL WORK LOCATIONS AND QUANTITIES USED AT THE ENGINEER'S DISCRETION SHALL BE MADE A MATTER OF RECORD BY INCORPORATION INTO THE FINAL CHANGE ORDER GOVERNING COMPLETION OF THIS PROJECT.

**ITEM SPECIAL - PRECONSTRUCTION VIDEO**

5 BUSINESS DAYS PRIOR TO BEGINNING OF CONSTRUCTION AND THE DELIVERY OF ANY MATERIALS OR SUPPLIES TO THE SITE THE CONTRACTOR SHALL PROVIDE A PRECONSTRUCTION DVD FOR THE PURPOSE OF ESTABLISHING THE EXISTING SURFACE CONDITIONS IN ALL AREAS TO BE AFFECTED BY CONSTRUCTION WORK.
