Construction Noise Ordinance Variance Request (CCO 605.10)

Dear Ms. Romanchok;

I am in receipt of your Noise Ordinance Variance request to waive enforcement of CCO §605.10 as it pertains to the Ohio Department of Transportation bridge deck repair Project.

Per your request, the work, if approved, will consist of the Ohio Department of Transportation (ODOT), repairing three bridge decks located along the mainline IR-77 over US-422 WB, East 22nd Street and East 14th Street.

To maintain traffic and lane closures, ODOT Is requesting to perform the following work activities during the overnight hours: removal of existing bridge decks, paving and striping, MOT phase changes and bridge deck pours. The project would start on or about the Spring of 2026 to be completed on or about the Summer of 2028. Night work would not take place every night of the year, dates will be determined as the phases of the project progresses.

To accommodate this work, ODOT is requesting a Noise Ordinance Variance to waive enforcement of CCO 605.10 as related to the CUY IR 077 bridge project in the area of IR-77 over US-422 WB, East 22nd Street and East 14th Street utilizing the following equipment: compressors, pneumatic drills, concrete pumps, excavators, dump trucks, rollers, water blasters, cranes, paint trucks, pavers, generators, loaders, hoe-reams, walk behind concrete saws, partner saw and milling machines.

After careful consideration and no further objections from Councilman Richard Starr, the request for a waiver of CCO §605.10 is **approved** with the following conditions:

- The work will be performed at the approved locations only and within the specified time frame outlined.
- The City of Cleveland Department of Public Safety and Councilman Richard Starr's office shall be notified at least twenty-four (24) hours in advance of any changes relative to the dates and hours of operations as referenced in this approval letter.
- The City of Cleveland Department of Public Safety and Councilman Richard Starr's office shall be notified at least twenty-four (24) hours In advance of the use of heavy equipment other than those mentioned in this approval letter.
- The City of Cleveland Department of Public Safety and Councilman Richard Starr's office shall be notified immediately of any changes relative to the dates and hours of operations as referenced in this approval letter.

Dear Assistant Director Carlton,

The Ohio Department of Transportation (ODOT) will be repairing bridge decks in the City of Cleveland. This project is necessary to improve deck condition on three bridges located along the mainline IR-77 over US-422 WB, East 22nd Street and East 14th Street.

Due to maintenance of traffic and lane closure restrictions, ODOT is requesting the following work activities be allowed at nighttime for this project:

- Removal of existing bridge decks
- Paving and Striping
- MOT phase changes
- Bridge deck pours

Construction is scheduled to begin in the Spring of 2026 and be completed in the Summer of 2028. Night-work would not take place every night of the year. Specific days would be determined as the phases of the project progress.

Anticipated equipment includes compressors, pneumatic drills, concrete pumps, excavators, dump trucks, rollers, water blasters, cranes, paint trucks, pavers, generators, loaders, hoe-rams, walk behind concrete saws, partner saws, and milling machines.







County Project Location Map
