GENERAL NOTES

MAINTENANCE OF TRAFFIC

A MINIMUM OF ONE LANE OF TRAFFIC IN EACH DIRECTION SHALL BE MAINTAINED AT ALL TIMES BY USE OF THE EXISTING PAVEMENT. LENGTH AND DURATION OF THE LANE CLOSURES AND RESTRICTIONS SHALL BE AT THE APPROVAL OF THE ENGINEER. IT IS THE INTENT TO MINIMIZE THE IMPACT TO THE TRAVELING PUBLIC. LANE CLOSURES OR RESTRICTIONS OVER SEGMENTS OF THE PROJECT IN WHICH NO WORK IS ANTICIPATED WITHIN A REASONABLE TIME FRAME, AS DIRECTED BY THE ENGINEER, SHALL NOT BE PERMITTED. THE LEVEL OF UTILIZATION OF MAINTENANCE OF TRAFFIC DEVICES SHALL BE COMMENSURATE WITH THE WORK IN PROGRESS.

ALL TRAFFIC CONTROL SIGNS, SIGNS, DEVICES, AND OPERATIONS USED FOR THE TEMPORARY MAINTENANCE AND CONTROL SHALL AT ALL TIMES BE SUBJECT TO THE DIRECTION AND CONTROL OF THE ENGINEER IN RESPECT TO THEIR CONDITION, LOCATIONS, AND TIMES OF APPLICATION. VISIBLE SIGNS AND DEVICES SHALL CONSISTENTLY REFLECT THE CONDITIONS ACTUALLY EXISTING. INAPPROPRIATE SIGNS AND DEVICES SHALL BE REMOVED OR COVERED.

THE CONTRACTOR SHALL BE RESPONSIBLE FOR FURNISHING, ERECTING OR REPLACING, MAINTAINING, AND REMOVING ALL TEMPORARY TRAFFIC CONTROL SIGNS AND DEVICES THAT MAY BE REQUIRED BY THE CMS AND/OR THE OHIO MANUAL FOR UNIFORM TRAFFIC CONTROL DEVICES FOR THE MAINTENANCE OF THROUGH TRAFFIC.

MAINTAIN TRAFFIC AS FOLLOWS:

- 1. ON TWO-LANE TWO-WAY ROADWAY MAINTAIN TRAFFIC IN IN ACCORDANCE WITH STANDARD DRAWING MT-99.20, FLAGGERS IN ACCORDANCE WITH STANDARD DRAWING MT-97.10 MAY BE USED AS REQUIRED TO PROGRESS THE THE WORK.
- 2. ON-MUTI- LANE ROADWAYS MAINTAIN TRAFFIC IN ACCORD-ANCE WITH STANDARD DRAWING MT-99.20, (USING FLASHING ARROW PANEL IN ACCORDANCE WITH STANDARD DRAWING

MT-95.30) AND LANE CLOSURES IN ACCORDANCE WITH

STANDARD DRAWINGS MT-95.30, MT-95.31, MT-98.10, MT-98.11, MT-98.22, MT-98.28, OR MT-98.29 AS APPLICABLE MAY BE USED ASREQUIRED TO PROGRESS WORK.

NO WORK SHALL BE PERFORMED AND ALL EXISTING LANES SHALL BE OPEN TO TRAFFIC DURING DESIGNATED HOLIDAYS OR EVENTS:

CHRISTMAS FOURTH OF JULY
NEWY YEARS LABOR DAY
MEMORIAL DAY THANKSGIVING
(OTHER HOLIDAY OR EVENT)

THE PERIOD OF TIME THAT THE LANES ARE TO BE OPEN DEPENDS ON THE DAY OF THE WEEK ON WHICH THE HOLIDAY OR EVENT FALLS. THE FOLLOWING SCHEDULE SHALL BE USED TO DETERMINE THIS PERIOD:

THE CONTRACTOR SHALL COMPLETE THE ORIGINAL WORK OF REPLACING THE EXISTING RAISED PAVEMENT MARKER REFLECTORS AND RPMS IN ALL EIGHT COUNTIES AT VARIOUS LOCATIONS IN DISTRICT 9 BY MAY 31ST, 2019. THE PROVISIONS OF 108.07 SHALL BE APPLICABLE TO THE DATE SET FOR COMPLETION OF ORIGINAL WORK.

THE ENGINEER WILL DETERMINE IF ANY OF THE ORIGINAL WORK IS UNACCEPTABLE AFTER THE ORIGINAL WORK HAS GONE THRU THE WINTER SEASON BEFORE FINAL ACCEPTANCE. RAISED PAVEMENT MARKERS WHICH ARE UNACCEPTABLE, OR BECOME UNACCEPTABLE PRIOR TO FINAL ACCEPTANCE, AS DETERMINED BY THE ENGINEER, FOR CAUSES SUCH AS, BUT NOT LIMITED TO.

IMPROPER INSTALLATION, EPOXY NOT HARDENING OR LOSS OF

ADHESION TO THE PAVEMENT OR BETWEEN THE CASTING AND THE PRISMATIC RETRO-REFLECTOR, LOSS OR IMPROPER REFLECTING PRISMATIC RETRO-REFLECTOR SHALL BE REPLACED BY THE CONTRACTOR WITH RPM MATERIALS CONFORMING TO THE SPECIFICATIONS AND REQUIREMENTS AT HIS EXPENSE WITHOUT DELAY. THE CONTRACTOR WILL RECEIVE NO PAYMENT FOR UNACCEPTABLE WORK THAT IS NON-PERFORMED.

THE FINAL CONTRACT COMPLETION DATE IN THE PROPOSAL IS THE DATE BY WHICH ANY RESULTING CORRECTIVE ACTION MUST BE COMPLETED.

CONTRACTOR IS NOT TO BEGIN CONSTRUCTION UNTIL JUNE 30, 2020.
