#### UTILITIES

THE CONTRACTOR SHALL BE RESPONSIBLE FOR CONTACTING ANY UTILITIES THAT MAY BE AFFECTED BY THE WORK PERFORMED FOR THIS CONTRACT. THE CONTRACTOR SHALL NOTIFY THE UTILITIES SUFFICIENTLY BEFORE WORK BEGINS SO THAT THE COMPANIES CAN LOCATE AND MARK THE LOCATION OF THEIR FACILITIES BEFORE ANY EXCAVATION OR POST DRIVING BEGINS. THE CONTRACTOR SHALL ALSO LOCATE AND AVOID UNDERGROUND DRAINAGE PIPES NOT ASSOCIATED WITH A PARTICULAR UTILITY COMPANY.

THIS ITEM SHALL CONSIST OF FURNISHING AND INSTALLING SRT-31 TYPE B ANCHOR ASSEMBLIES BY VALTIR LLC COMPATIBLE WITH TYPE MGS GUARDRAIL AS LISTED ON ROADWAY ENGINEERING'S WEB PAGE UNDER ROADSIDE SAFETY DEVICES FOR APPROVED GUARDRAIL END TREATMENTS. INSTALLATION SHALL BE AT THE LOCATIONS SPECIFIED IN THE PLANS, IN ACCORDANCE WITH THE MANUFACTURER'S SPECIFICATIONS.

REFER TO THE MANUFACTURER'S INSTRUCTIONS REGARDING THE INSTALLATION OF, AND THE GRADING AROUND, THE FOUNDATION TUBES AND GROUND STRUT. THE TOP OF ANY FOUNDATION TUBE SHOULD BE LESS THAN 4 INCHES ABOVE THE GROUND. THE PLACEMENT OF THE FOUNDATION TUBES SHOULD BE AN APPROPRIATE DEPTH BELOW THE LEVEL LINE IN ORDER TO MAINTAIN THE FINISHED GUARDRAIL HEIGHT OF 31 INCHES FROM THE EDGE OF THE SHOULDER.

THE FACE OF THE TYPE B IMPACT HEAD SHALL BE COVERED WITH TYPE G REFLECTIVE SHEETING. PER CMS 730.19.

PAYMENT FOR THE ABOVE WORK SHALL BE MADE AT THE UNIT PRICE BID FOR ITEM 606. GUARDRAIL MISC.: ANCHOR ASSEMBLY, MGS TYPE B, EACH, AND SHALL INCLUDE ALL LABOR, TOOLS. EQUIPMENT AND MATERIALS NECESSARY TO CONSTRUCT A COMPLETE AND FUNCTIONAL ANCHOR ASSEMBLY SYSTEM. INCLUDING REFLECTIVE SHEETING AND ALL RELATED HARDWARE, GRADING, EMBANKMENT AND EXCAVATION NOT SEPARATELY SPECIFIED, AS REQUIRED BY THE MANUFACTURER.

#### ITEM 606 - ANCHOR ASSEMBLY. MGS TYPE E

THIS ITEM SHALL CONSIST OF FURNISHING AND INSTALLING ANY OF THE GUARDRAIL END TERMINALS FOR TYPE MGS GUARDRAIL AS LISTED ON ROADWAY ENGINEERING'S WEB PAGE UNDER ROADSIDE SAFETY DEVICES FOR APPROVED GUARDRAIL END TREATMENTS. INSTALLATION SHALL BE AT THE LOCATIONS SPECIFIED IN THE PLANS, IN ACCORDANCE WITH THE MANUFACTURER'S SPECIFICATIONS.

THE FACE OF THE TYPE E IMPACT HEAD SHALL BE COVERED WITH A SHEET OF TYPE G REFLECTIVE SHEETING, PER CMS 730.19.

REFER TO THE MANUFACTURER'S INSTRUCTIONS REGARDING THE INSTALLATION OF, AND THE GRADING AROUND THE FOUNDATION TUBES AND GROUND STRUT. EQUIPMENT AND MATERIALS NECESSARY TO CONSTRUCT A COMPLETE AND FUNCTIONAL ANCHOR ASSEMBLY SYSTEM. INCLUDING ALL RELATED TRANSITIONS, REFLECTIVE SHEETING. HARDWARE. GRADING. EMBANKMENT AND EXCAVATION NOT SEPARATELY SPECIFIED. AS REQUIRED BY THE MANUFACTURER.

# **GUARDRAIL POST HOLES**

ALL HOLES REMAINING AFTER REMOVAL OF GUARDRAIL POSTS WILL BE FILLED WITH GRANULAR MATERIAL. EXCESS MATERIAL RESULTING FROM GUARDRAIL RECONSTRUCTION OR EXCESS MATERIAL FROM BERM RESHAPING . ALL FILL MATERIAL WILL BE APPROVED BY THE ENGINEER. MATERIAL PLACED IN HOLES WILL BE THOROUGHLY COMPACTED AND LEVELED OFF AS DIRECTED BY THE ENGINEER. PAYMENT FOR THE ABOVE WILL BE INCLUDED IN THE UNIT PRICE BID FOR THE APPLICABLE GUARDRAIL ITEM.

### ITEM 614, MAINTAINING TRAFFIC

ONE LANE OF TRAFFIC SHALL BE MAINTAINED AT ALL TIMES.

ALL WORK AND TRAFFIC CONTROL DEVICES SHALL BE IN ACCORDANCE WITH C&MS 614 AND OTHER APPLICABLE PORTIONS OF THE SPECIFICATIONS, AS WELL AS THE OHIO MANUAL OF UNIFORM TRAFFIC CONTROL DEVICES. PAYMENT FOR ALL LABOR, EQUIPMENT AND MATERIALS SHALL BE INCLUDED IN THE LUMP SUM CONTRACT PRICE FOR ITEM 614. MAINTAINING TRAFFIC. UNLESS SEPARATELY ITEMIZED IN THE PLAN.

# ITEM 606.04 - ERECTING RAIL ELEMENT

AFTER INSTALLATION, THE GUARDRAIL BOLT SHALL NOT BE TRIMMEDOR OTHERWISE ALTERED SO THAT THE NUT AND WASHER MAY BE REMOVED AT A LATER DATE.

### **GUARDRAIL**

THE LOG POINTS OF THE PROPOSED GUARDRAIL SHOWN ARE APPROXIMATE. EXACT LOCATIONS WILL BE DETERMINED BY THE ENGINEER. MAIL BOXES THAT INTERFERE WITH THE REMOVAL OR REPLACEMENT OF GUARDRAIL WILL BE RELOCATED BY THE CONTRACTOR AS APPROVED BY THE ENGINEER. THE COST OF THIS ITEMWILL BE INCLUDED IN THE UNIT PRICE BID FOR THE APPLICABLE GUARDRAIL ITEM.

#### MAINTENANCE OF TRAFFIC

BERM RESHAPING AND GUARDRAIL REMOVAL AND CONSTRUCTION WILL BE PERFORMED ONLY ON ONE SIDE OF THE PAVEMENT AT ANY GIVEN TIME.

ALL TRAFFIC CONTROL DEVICES REQUIRED INSIDE THE WORK LIMITS. EXCEPT REGULATORY. GUIDE SIGNS. AND PAVEMENT MARKINGS SHALL BE FURNISHED. ERECTED AND MAINTAINED BY THE CONTRACTOR.

### LOCATION OF GUARDRAIL

THE LOCATIONS OF GUARDRAIL RUNS. AS SHOWN IN THESE PLANS. ARE SUBJECT TO ADJUSTMENT TO ASSURE THAT THE PLANNED INSTALLATIONS WILL AFFORD MAXIMUM PROTECTION FOR TRAFFIC.

#### **PUBLIC SAFETY**

THE PERIOD OF TIME THAT ANY HAZARD IS LEFT UNPROTECTED BY GUARDRAIL SHALL BE HELD TO AN ABSOLUTE MINIMUM, AND IN NO CASE SHALL SUCH PERIOD BE LONGER THAN TWO (2) DAYS.

FOR SAFETY PURPOSES. NO EQUIPMENT. PRIVATE VEHICLE. OR MATERIAL SHALL BE PARKED OR STORED WITHIN 30 FEET OF THE OUTSIDE EDGE OF THE PAVEMENT UNLESS 6 FEET BEHIND THE **GUARDRAIL** 

## CONNECTION BETWEEN EXISTING AND PROPOSED GUARDRAIL

WHEN IT IS NECESSARY TO SPLICE PROPOSED GUARDRAIL TO EXISTING GUARDRAIL. ONLY THE EXISTING GUARDRAIL SHALL BE CUT. DRILLED, OR PUNCHED. THE CONNECTION SHALL BE MADE USING A "W-BEAM RAIL SPLICE" AS SHOWN IN AASHTO M 180. PAYMENT SHALL BE INCLUDED IN THE CONTRACT PRICE FOR THE RESPECTIVE GUARDRAIL ITEMS.

### ITEM 202, GUARDRAIL REMOVED

POSTS AND MICELLANEOUS HARDWARE DESIGNATED FOR REMOVAL BECOME THE PROPERTY OF THE CONTRACTOR AND SHALL BE DISPOSED OF. PAYMENT FOR THE ABOVE SHALL BE INCLUDED IN THE UNIT BID PRICE FOR ITEM 202 GUARDRAIL REMOVED.

#### NOTIFICATION OF TRAFFIC RESTRICTIONS

THROUGHOUT THE DURATION OF THE PROJECT. THE CONTRACTOR SHALL NOTIFY THE PROJECT ENGINEER IN WRITING OF ALL TRAFFIC RESTRICTIONS AND UPCOMING MAINTENANCE OF TRAFFIC CHANGES. THE CONTRACTOR SHALL ENSURE THE WRITTEN NOTIFICATION IS SUBMITTED IN A TIMELY MANNER TO ALLOW THE PROJECT ENGINEER TO MEET THE REQUIRED TIME FRAMES SET FORTH IN THE TABLE BELOW TO INFORM SPECIAL HAULING PERMITS SECTION (HAULING.PERMITS@DOT.OHIO.GOV) AND THE DISTRICT PUBLIC INFORMATION OFFICE (PIO). THIS NOTIFICATION SHALL BE RECEIVED BY THE PROJECT ENGINEER PRIOR TO THE PHYSICAL SETUP OF ANY APPLICABLE SIGNS OR MESSAGE BOARDS.

INFORMATION SHOULD INCLUDE, BUT IS NOT LIMITED TO, ALL CONSTRUCTION ACTIVITIES THAT IMPACT OR INTERFERE WITH TRAFFIC AND SHALL LIST THE SPECIFIC LOCATION, TYPE OF WORK, ROAD STATUS, DATE AND TIME OF RESTRICTION, DURATION OF RESTRICTION, NUMBER OF LANES MAINTAINED, NUMBER OF LANES CLOSED, MINIMUM VERTICAL CLEARANCE, MINIMUM WIDTH OF DRIVABLE PAVEMENT. DETOUR ROUTES, IF APPLICABLE, AND ANY OTHER INFORMATION REQUESTED BY THE PROJECT ENGINEER.
