WORK ZONE PAVEMENT MARKINGS AND SIGNS

THE CONTRACTOR SHALL BE REQUIRED TO INSTALL WORK ZONE MARKINGS AND SIGNS AT EACH STRUCTURE AND AT LOCATIONS IDENTIFIED BY THE ENGINEER PER THE REQUIREMENTS OF C&MS 614.04 AND 614.11.

ALL WORK ZONE PAVEMENT MARKINGS SHALL BE PLACED PRIOR TO OPENING THE LANE TO TRAFFIC.

WORK ZONE PAVEMENT MARKINGS SHALL BE 642 PAINT.

PRIOR TO PLACEMENT OF ANY WORK ZONE PAVEMENT MARKINGS, THE CONTRACTOR SHALL COMPLETELY OBLITERATE, AS PER C&MS 641.10, ALL EXISTING PAVEMENT MARKINGS THAT WOULD CREATE CONFUSION OR CONFLICT WITH THE WORK ZONE PAVEMENT MARKINGS

THE FOLLOWING ESTIMATED QUANTITIES HAVE BEEN CARRIED TO THE GENERAL SUMMARY FOR WORK ZONE PAVEMENT MARKINGS:

ITEM 614 - MAINTAINING TRAFFIC

TRAFFIC ON FOUR-LANE HIGHWAYS (I.R. 77 LOCATIONS) SHALL BE MAINTAINED AT ALL TIMES BY MEANS OF A SINGLE LANE CLOSURE AS SHOWN ON STD. DWG. MT-95.30 AND IN ACCORDANCE WITH THE OHIO MANUAL OF UNIFORM TRAFFIC CONTROL DEVICES. OPERATIONS SHALL BE DURING DAYLIGHT HOURS ONLY.

TRAFFIC ON TWO-LANE HIGHWAYS (U.S. 36 & U.S. 22 LOCATIONS) SHALL BE MAINTAINED AT ALL TIMES BY MEANS OF A SINGLE LANE CLOSURE AS SHOWN ON STD. DWG. MT-97.10 AND IN ACCORDANCE WITH THE OHIO MANUAL OF UNIFORM TRAFFIC CONTROL DEVICES. OPERATIONS SHALL BE DURING DAYLIGHT HOURS ONLY

NO WORK SHALL BE PERFORMED AND ALL EXISTING LANES SHALL BE OPEN TO TRAFFIC, DURING THE FOLLOWING DESIGNATED HOLIDAYS OR EVENTS:

> FOURTH OF JULY LABOR DAY

THE PERIOD OF TIME THAT THE LANES ARE TO BE OPEN DEPENDS ON THE DAY OF THE WEEK ON WHICH THE HOLIDAY OR EVENT FALLS. THE FOLLOWING SCHEDULE SHALL BE USED TO DETERMINE THIS PERIOD:

DAY OF HOLIDAY TIME ALL LANES MUST BE OPEN TO TRAFFIC: OR EVENT:

SHOULD THE CONTRACTOR FAIL TO MEET ANY OF THESE REQUIREMENTS ON LOCATIONS ON I.R. 77, THE CONTRACTOR SHALL BE ASSESSED A DISINCENTIVE PER THE LANE VALUE CONTRACT (PN127).

SHOULD THE CONTRACTOR FAIL TO MEET ANY OF THESE REQUIREMENTS ON LOCATIONS ON U.S. 22, THE CONTRACTOR SHALL BE ASSESSED A DISINCENTIVE OF \$1200 PER HOUR THE ABOVE DESCRIBED LANE CLOSURE RESTRICTIONS ARE VIOLATED.

SHOULD THE CONTRACTOR FAIL TO MEET ANY OF THESE REQUIREMENTS ON LOCATIONS ON U.S. 36. THE CONTRACTOR SHALL BE ASSESSED A DISINCENTIVE OF \$2700 PER HOUR THE ABOVE DESCRIBED LANE CLOSURE RESTRICTIONS ARE VIOLATED.

ITEM 614 - MAINTAINING TRAFFIC

(CONTINUED...)

LENGTH AND DURATION OF LANE CLOSURES AND RESTRICTIONS SHALL BE AT THE APPROVAL OF THE ENGINEER. IT IS THE INTENT TO MINIMIZE THE IMPACT TO THE TRAVELING PUBLIC. LANE CLOSURES OR RESTRICTIONS OVER SEGMENTS OF THE PROJECT IN WHICH NO WORK IS ANTICIPATED WITHIN A REASONABI E TIME FRAME, AS DETERMINED BY THE ENGINEER SHALL NOT BE PERMITTED. THE LEVEL OF UTILIZATION OF MAINTENANCE OF TRAFFIC DEVICES SHALL BE COMMENSURATE WITH THE WORK IN PROGRESS.

ALL WORK AND TRAFFIC CONTROL DEVICES SHALL BE IN ACCORDANCE WITH ITEM 614 AND OTHER APPLICABLE PORTIONS OF THE SPECIFICATIONS, AS WELL AS THE OHIO MANUAL OF UNIFORM TRAFFIC CONTROL DEVICES. PAYMENT FOR ALL LABOR. EQUIPMENT, AND MATERIALS SHALL BE INCLUDED IN THE LUMP SUM CONTRACT PRICE FOR ITEM 614, MAINTAINING TRAFFIC, UNLESS SEPARATELY ITEMIZED IN THE PLAN.

WATERS OF THE US

WATERS OF THE US HAVE BEEN IDENTIFIED WITHIN THE PROJECT AREA THE CONTRACTOR SHALL EXERCISE CAUTION TO ENSURE THAT NO IMPACTS OCCUR TO WATERS OF THE US. NO TEMPORARY OR PERMANENT FILL OF ANY TYPE MAY BE PLACED IN ANY STREAM OR WETLAND AS PART OF THIS PROJECT. ANY ACTIVITIES OCCURRING IN STREAMS OR WETLANDS WOULD REQUIRE PERMITS FROM THE US ARMY CORPS OF ENGINEERS AND/OR THE OHIO EPA.

ANY OTHER SITE PROPOSED BY THE CONTRACTOR FOR OFF PROJECT ANCILLARY CONSTRUCTION (STAGING AREAS, WASTE LOCATIONS, AND/OR BORROW LOCATIONS) MUST MEET THE REQUIREMENTS OF CMS 105.16.

THIS NOTIFICATION SHALL BE RECEIVED BY THE PROJECT ENGINEER PRIOR TO THE PHYSICAL SETUP OF ANY APPLICABLE SIGNS OR MESSAGE BOARDS.

INFORMATION SHOULD INCLUDE, BUT IS NOT LIMITED TO, ALL CONSTRUCTION ACTIVITIES THAT IMPACT OR INTERFERE WITH TRAFFIC AND SHALL LIST THE SPECIFIC LOCATION. TYPE OF WORK, ROAD STATUS, DATE AND TIME OF RESTRICTION. DURATION OF RESTRICTION, NUMBER OF LANES MAINTAINED, NUMBER OF LANES CLOSED, MINIMUM VERTICAL CLEARANCE, MINIMUM WIDTH OF DRIVABLE PAVEMENT, DETOUR ROUTES, IF APPLICABLE, AND ANY OTHER INFORMATION REQUESTED BY THE PROJECT ENGINEER.
