MAINTENANCE OF TRAFFIC SIGNAL/FLASHER INSTALLATION

THE CONTRACTOR SHALL BE RESPONSIBLE FOR MAINTAINING
TRAFFIC SIGNAL/FLASHER INSTALLATIONS WITHIN THE PROJECT
UNDER THE FOLLOWING CONDITIONS:

- 1. EXISTING SIGNAL/FLASHER INSTALLATIONS WHICH THE PLANS REQUIRE THE CONTRACTOR TO ADJUST, MODIFY, ADD ONTO OR REMOVE, OR WHICH THE CONTRACTOR ACTUALLY ADJUSTS, MODIFIES OR OTHERWISE DISTURBS. THE CONTRACTOR SHALL BE RESPONSIBLE FOR THE ENTIRE INSTALLATION (AT AN INTERSECTION) FROM THE TIME HIS OPERATIONS FIRST DISTURB THE INSTALLATION UNTIL THE INSTALLATION HAS BEEN SUBSEQUENTLY REMOVED OR MODIFIED AND THE WORK IS ACCEPTED.
- 2. NEW OR REUSED SIGNAL/FLASHER INSTALLATIONS OR DEVICES, INSTALLED BY THE CONTRACTOR. THE CONTRACTOR SHALL BE RESPONSIBLE FOR MAINTENANCE OF THESE FROM THE TIME OF INSTALLATION UNTIL THE WORK IS ACCEPTED.

THE CONTRACTOR SHALL CORRECT AS QUICKLY AS POSSIBLE ALL OUTAGES OR MALFUNCTIONS. HE SHALL PROVIDE THE MAINTAINING AGENCY AND THE ENGINEER SUCH ADDRESSES AND PHONE NUMBERS WHERE HIS MAINTENANCE FORCES CAN BE CONTACTED. THE CONTRACTOR SHALL PROVIDE ONE OR MORE PERSONS TO RECEIVE ALL CALLS AND DISPATCH THE NECESSARY MAINTENANCE FORCES TO CORRECT OUTAGES. SUCH A PERSON OR PERSONS MAY BE USED TO PERFORM OTHER DUTIES AS LONG AS PROMPT ATTENTION IS GIVEN TO THESE CALLS AND A PERSON IS READILY AVAILABLE CONTINUOUSLY 24 HOURS A DAY, 7 DAYS A WEEK. ALL LAMP OUTAGES, CABLE OUTAGES, ELECTRICAL FAILURES, EQUIPMENT MALFUNCTIONS AND MISALIGNED SIGNAL HEADS SHALL BE CORRECTED TO THE SATISFACTION OF THE ENGINEER WITH THE SIGNAL BACK TO SERVICE WITHIN FOUR HOURS AFTER THE CONTRACTOR HAS BEEN NOTIFIED OF THE OUTAGE.

IN THE EVENT NEW SIGNALS ARE DAMAGED PRIOR TO
ACCEPTANCE, ALL DAMAGED EQUIPMENT EXCEPT POLES
AND CONTROL EQUIPMENT SHALL BE REPLACED BY THE
CONTRACTOR TO THE SATISFACTION OF THE ENGINEER
WITH THE SIGNAL BACK IN SERVICE WITHIN 8 HOURS AFTER
THE CONTRACTOR'S NOTIFICATION OF THE OUTAGE. THE
CONTRACTOR SHALL ARRANGE FOR FULL TRAFFIC CONTROL
UNTIL THE SIGNAL IS BACK IN OPERATION. IF POLES AND/OR
CONTROL EQUIPMENT ARE DAMAGED AND MUST BE REPLACED,
THE CONTRACTOR SHALL MAKE TEMPORARY REPAIRS AS
NECESSARY TO BRING THE SIGNAL BACK INTO FULL OPERATION
WITHIN THE ALLOWED 8-HOUR PERIOD, AND SHALL MAKE
PERMANENT REPAIRS OR REPLACEMENT AS SOON THEREAFTER
AS POSSIBLE.

NONE OF THE ABOVE SHALL BE CONSTRUED AS COLLECTIVE OR CONSECUTIVE OUTAGE TIME PERIODS AT ANY ONE LOCATION. THAT IS, WHERE MORE THAN ONE OUTAGE OCCURS AT ANY ONE LOCATION THEN THE ALLOTTED TIME LIMIT SHALL BE FOR THE WORST SINGLE OUTAGE.

WHERE OUTAGES ARE THE DIRECT RESULT OF A VEHICLE
ACCIDENT THE RESPONSE OF THE CONTRACTOR SHALL BE AS
OUTLINED ABOVE. THE CONTRACTOR SHALL BE RESPONSIBLE
FOR COLLECTION OF ANY COMPENSATION FOR THIS WORK
FROM THOSE PARTIES RESPONSIBLE FOR THE DAMAGE.

WHERE THE CONTRACTOR HAS FAILED TO, OR CANNOT RESPOND TO, AN OUTAGE OR SIGNAL EQUIPMENT MALFUNCTION, AT THESE LOCATIONS WITHIN HIS RESPONSIBILITY, WITHIN PERIODS AS SPECIFIED ABOVE, THE ENGINEER MAY INVOKE THE PROVISIONS OF SECTION 105.15 AND ANY SUBSEQUENT BILLINGS TO THE STATE OR THE CITY OF CHARDON FOR POLICE SERVICES AND MAINTENANCE SERVICES BY CITY FORCES SHALL BE DEDUCTED FROM MONIES DUE OR TO BECOME DUE THE CONTRACTOR IN ACCORDANCE WITH PROVISIONS OF SECTION 105.15.

THE CONTRACTOR SHALL PROVIDE THE MAINTENANCE SERVICE ENTIRELY WITH HIS FORCES OR HE MAY CHOOSE TO ENTER INTO A COOPERATIVE UNDERSTANDING WITH THE LOCAL MAINTAINING AGENCY TO PROVIDE THE MAINTENANCE. THE CONTRACTOR SHALL INFORM THE ENGINEER, IN WRITING, OF THE MAINTENANCE METHOD SELECTED.

THE CONTRACTOR SHALL BE RESPONSIBLE FOR ANY DAMAGE
TO ANY TRAFFIC SIGNAL COMPONENTS REQUIRED TO BE
HANDLED DURING THE RELOCATION OF POLES AND REVISIONS
TO THE SIGNAL SYSTEM. WHEN A TRAFFIC SIGNAL MUST BE
TAKEN OUT OF SERVICE BY THE CONTRACTOR, DUE TO CONSTRUCTION PROCEDURES, THIS OUTAGE SHALL NOT EXCEED
2 HOURS AND SHALL NOT INCLUDE THE HOURS OF 9:00 PM
TO 7:00 AM. ANY SIGNALIZED INTERSECTION, WHERE THE SIGNAL
IS OUT OF SERVICE DUE TO CONSTRUCTION PROCEDURES, OR
DUE TO AN OUTAGE OR MALFUNCTION OF EQUIPMENT AS
DESCRIBED ABOVE, SHALL BE PROTECTED, BY THE CONTRACTOR,
BY THE INSTALLATION OF TEMPORARY "STOP" SIGNS, EXCEPT
FOR THE FOLLOWING INTERSECTIONS WHICH SHALL BE
PROTECTED BY OFF-DUTY CITY OF CHARDON POLICE, HIRED
BY THE CONTRACTOR:

1. MAYFIELD ROAD (U.S. 322) AND AUBURN ROAD

- 2. MAYFIELD ROAD (U.S. 322) AND BASS LAKE ROAD
- 3. SOUTH STREET (S.R. 44) AND WOODIEBROOK ROAD
- 4. SOUTH STREET (S.R. 44) AND MAYFIELD ROAD (U.S. 322)

ANY VEHICULAR TRAFFIC SIGNAL HEAD, EITHER NEW OR EXISTING WHICH WILL BE OUT OF OPERATION SHALL BE COVERED IN THE MANNER DESCRIBED IN 632.25.

THE CONTRACTOR SHALL MAINTAIN COMPLETE RECORDS OF MALFUNCTIONS INCLUDING:

- 1. TIME OF NOTIFICATION OF MALFUNCTION;
- 2. TIME OF WORK CREWS ARRIVAL TO CORRECT THE MALFUNCTION;
- 3. ACTIONS TAKEN TO CORRECT THE MALFUNCTION, INCLUDING A LIST OF PARTS REPAIRED OR REPLACED;
- 4. A DIAGNOSIS OF REASON FOR THE MALFUNCTION AND PROBABILITY OF REOCCURRENCE;
- 5. TIME OF COMPLETION OF THE REPAIR AND SYSTEM RESTORED TO FULL SERVICE.

A COPY OF THESE RECORDS SHALL BE PROVIDED TO THE ENGINEER WITHIN THREE (3) WORKING DAYS FOLLOWING COMPLETION OF EACH REPAIR.

ALL COSTS RESULTING FROM THE ABOVE REQUIREMENTS
SHALL BE CONSIDERED TO BE INCLUDED IN THE LUMP SUM
PRICE BID FOR ITEM 614, MAINTAINING TRAFFIC.

DELINEATION OF TEMPORARY AND PERMANENT GUARDRAIL

BARRIER REFLECTORS SHALL BE INSTALLED ON ALL TEMPORARY GUARDRAIL USED FOR TRAFFIC CONTROL; AND, ON ALL PERMANENT GUARDRAIL LOCATED WITHIN 5 FEET OF THE EDGE OF THE ADJACENT TRAVEL LANE. BARRIER REFLECTORS SHALL CONFORM TO C&MS 626 AND THE SPACING SHALL BE APPROXIMATELY 50 FEET.

OBJECT MARKERS SHALL BE INSTALLED ON ALL TEMPORARY AND PERMANENT GUARDRAIL LOCATED WITHIN 5 FEET OF THE EDGE OF THE ADJACENT TRAVEL LANE. GUARDRAIL-MOUNTING OF OBJECT MARKERS SHALL BE MADE BY INSTALLING THE OBJECT MARKERS ON THE EXTENSION BLOCKS RATHER THAN DIRECTLY ONTO THE GUARDRAIL ITSELF.
