MAINTENANCE DURING CONSTRUCTION

THE CONTRACTOR SHALL TAKE ALL NECESSARY PRECAUTIONS TO PREVENT DAMAGE TO THE EXISTING PAVEMENT SURFACE DURING THE CONSTRUCTION OF THE PROPOSED DRILLED SHAFT WALL. THE CONTRACTOR SHALL BE RESPONSIBLE FOR ANY DAMAGE DONE BY THEIR EQUIPMENT.

ITEM 441 - ASPHALT CONCRETE INTERMEDIATE COURSE, TYPE 1, (449), (UNDER GUARDRAIL) AS PER PLAN

THIS OPERATION SHALL INCLUDE PREPARATION OF THE **GRADED SHOULDER USING ITEM 209 - RESHAPING UNDER** GUARDRAIL, AS PER PLAN AND PAVING UNDER THE GUARDRAIL USING ITEM 441 - ASPHALT CONCRETE INTERMEDIATE COURSE. TYPE 1, (449), (UNDER GUARDRAIL) AS PER PLAN.

HERBICIDE SHALL BE EPA APPROVED FOR PAVING UNDER GUARDRAIL. IT SHALL BE APPLIED TO THE PREPARED AREA AFTER FINAL LEVELING AND GRADING HAS BEEN COMPLETED. THE APPLICATION SHALL BE JUST PRIOR TO PAVING AND SHALL STRICTLY ADHERE TO THE MANUFACTURER'S INSTRUCTIONS.

EACH SUCCESSFUL BIDDER MUST BE LICENSED BY THE OHIO DEPARTMENT OF AGRICULTURE AS A COMMERCIAL APPLICATOR AND ALL PERSONS INVOLVED IN THE ACTUAL SPRAYING SHALL BE LICENSED AS COMMERCIAL OPERATORS IN THE APPROPRIATE SPRAY CATEGORY.

HERBICIDE LABEL. MATERIAL SAFETY DATA SHEET AND COPY OF APPLICATORS LICENSES SHALL BE SUBMITTED TO THE ENGINEER FOR VERIFICATION PRIOR TO COMMENCING WORK.

PAVING UNDER GUARDRAIL SHALL CONSIST OF PLACING ITEM 441 TO A DEPTH OF 3" AND A MAXIMUM WIDTH OF 4' USING ONE OF THE FOLLOWING METHODS:

METHOD A: 1. SET GUARDRAIL POSTS

2. PLACE ITEM 441

METHOD B:

1. PLACE ITEM 441 2. BORE ASPHALT AT POST LOCATIONS (MAY BE OMITTED IF STEEL POSTS ARE USED) 3. SET GUARDRAIL POSTS 4. PATCH AROUND POSTS. THE MATERIALS USED FOR PATCHING SHALL BE AN ASPHALT CONCRETE APPROVED BY THE ENGINEER. PATCHED AREAS SHALL BE COMPACTED USING EITHER HAND OR MECHANICAL METHODS. FINISHED SURFACES SHALL BE SMOOTH AND SLOPE TO DRAIN AWAY FROM THE POSTS.

ITEM 611 - CONDUIT MISC.: MONITOR CONDITION OF EXISTING 168" CMP

THE CONTRACTOR SHALL ACTIVELY MONITOR THE SHAPE AND CONDITION OF THE EXISTING 168" CMP CULVERT DURING THE INSTALLATION OF THE ADJACENT DRILLED SHAFTS.

THE CONTRACTOR SHALL FURNISH, INSTALL, AND SUBSEQUENTLY REMOVE ANY TEMPORARY BRACING NEEDED TO ENSURE THAT THE DRILLED SHAFT OPERATIONS DO NOT DAMAGE THE EXISTING 168" CMP CULVERT. IF ANY SHAPE CHANGE OR DAMAGE IS DETECTED, THE CONTRACTOR MUST IMMEDIATELY CEASE THE DRILLED SHAFT CONSTRUCTION OPERATIONS.

THE CONTRACTOR SHALL PERFORM A VIDEO INSPECTION OF THE BEFORE CONSTRUCTION CONDITION AND AFTER CONSTRUCTION CONDITION OF THE PIPE. VIDEO TO BE PROVIDED TO THE ENGINEER.

ALL LABOR, EQUIPMENT, AND MATERIALS REQUIRED TO PERFORM THE WORK OUTLINED ABOVE SHALL BE INCLUDED IN THE LUMP SUM PRICE BID FOR ITEM 611 - CONDUIT MISC.: MONITOR CONDITION OF EXISTING 168" CMP.

REVIEW OF DRAINAGE FACILITIES

PRIOR TO THE START OF WORK AND AGAIN BEFORE FINAL ACCEPTANCE, PERFORM AN INSPECTION WITH REPRESENTATIVES OF THE DEPARTMENT, CONTRACTOR AND LOCALS OF ALL EXISTING DRAINAGE FACILITIES THAT ARE TO REMAIN IN SERVICE WHICH MAY BE AFFECTED BY THE WORK. THE CONDITION OF THE EXISTING CONDUITS AND THEIR APPURTENANCES IS DETERMINED FROM FIELD **OBSERVATIONS. RECORDS OF THE INSPECTION ARE** MAINTAINED BY THE DEPARTMENT.

CONFIRM ALL EXISTING SEWERS INSPECTED INITIALLY BY THE ABOVE-MENTIONED PARTIES ARE MAINTAINED AND LEFT IN A CONDITION COMPARABLE TO THAT DETERMINED BY THE ORIGINAL INSPECTION. THE CONTRACTOR IS RESPONSIBLE TO CORRECT ANY CHANGE IN THE CONDITION RESULTING FROM THEIR OPERATIONS AS DIRECTED AND APPROVED BY THE ENGINEER.

PRIOR TO THE START OF WORK AND AGAIN BEFORE FINAL ACCEPTANCE. THE CONTRACTOR SHALL PERFORM AN INSPECTION OF THE EXISTING 168" CMP CULVERT AND DOCUMENT THE CONDITION OF THE STRUCTURE. THE RECORD OF THESE INSPECTIONS ARE TO BE MAINTAINED BY ODOT DISTRICT 12.

PAYMENT FOR ALL OPERATIONS DESCRIBED ABOVE SHALL BE INCLUDED IN THE CONTRACT PRICE FOR THE PERTINENT 611 CONDUIT ITEMS.

FEDERALLY ENDANGERED SPECIES INDIANA BAT AND NORTHERN LONG-EARED BAT

THE PROJECT IS LOCATED WITHIN THE KNOWN HABITAT RANGES OF THE FEDERALLY LISTED AND PROTECTED INDIANA BAT AND NORTHERN LONG-EARED BAT. NO TREES SHALL BE REMOVED UNDER THIS PROJECT FROM APRIL 1 THROUGH SEPTEMBER 30. ALL NECESSARY TREE REMOVAL SHALL OCCUR FROM OCTOBER 1 THROUGH MARCH 31. THIS REQUIREMENT IS NECESSARY TO AVOID AND MINIMIZE IMPACTS TO THESE SPECIES AS REQUIRED BY THE ENDANGERED SPECIES ACT. FOR THE PURPOSES OF THIS NOTE, A TREE IS DEFINED AS A LIVE, DYING, OR DEAD WOODY PLANT. WITH A TRUNK THREE INCHES OR GREATER IN DIAMETER AT A HEIGHT OF 4.5 FEET ABOVE THE GROUND SURFACE, AND WITH A MINIMUM HEIGHT OF 13 FEET.

ITEM 614 - MAINTAINING TRAFFIC

ALL WORK AND TRAFFIC CONTROL DEVICES SHALL BE IN ACCORDANCE WITH 614 AND OTHER APPLICABALE PORTIONS OF THE SPECIFICATIONS, AS WELL AS THE OHIO MANUAL OF UNIFORM TRAFFIC CONTROL DEVICES. CURRENT EDITION. LATEST REVISION.

THE EXISTING NUMBER OF TRAVEL LANES FOR EB SHALL BE MAINTAINED AT ALL TIMES EXCEPT AS PER THE D- 12 PERMITTED LANE CLOSURE CHARTS LISTED HERE: HTTPS://WWW.DOT.STATE.OH.US/DISTRICTS/D12/ HIGHWAYMANAGEMENT/PAGES/PERMITTEDLANECLOSURES.ASPX.

WHEN LANE CLOSURES ARE PERMITTED, WORK ZONE MAY BE ESTABLISHED SUCH THAT I-90 EB MAY BE REDUCED BY 1 LANE. TWO LANES SHALL BE MAINTAINED DURING THE RUMBLE STRIPS REMOVAL AND REPLACEMENT OPERATIONS.

SIGNS FURNISHED SHALL BE IN NEW OR LIKE NEW CONDITIONS. LIKE NEW SIGNS SHALL BE SUBJECT TO THE APPROVAL OF THE PROJECT ENGINEER. THE CONTRACTOR SHALL BE RESPONSIBLE AT ALL TIMES FOR PROVIDING AND MAINTAINING LIGHTS. SIGNS. AND BARRICADES FOR THE MAINTENANCE OF TRFFIC AND SAFETY OF HIS/HER WORK AT THE LOCATIONS SHOWN ON THESE PLANS OR AS DIRECTED BY THE ENGINEER.

IF THE CONTRACTOR FAILS TO COMPLY WITH THE PROVISIONS FOR TRAFFIC CONTROL AS SET FORTH IN THESE PLANS AND PROVISIONS OF THE OMUTCD AND THE FAILURE RESULTS IN A CONDITION AT THE WORK SITE WHICH IS UNSAFE FOR TRAFFIC. THE ENGINEER SHALL SUSPEND WORK UNTIL THE CONTRACTOR COMPLIES WITH THE NECESSARY REQUIREMENTS.

ALL WORK AND TRAFFIC CONTROL DEVICES SHALL BE IN ACCORDANCE WITH CMS 614 AND OTHER APPLICABLE PORTIONS OF THE SPECIFICATIONS. AS WELL AS THE OHIO MANUAL OF UNIFORM TRAFFIC CONTROL DEVICES. PAYMENT FOR ALL LABOR. EQUIPMENT AND MATERIALS SHALL BE INCLUDED IN THE LUMP SUM CONTRACT PRICE FOR ITEM 614, MAINTAINING TRAFFIC. UNLESS SEPARATELY ITEMIZED IN THE PLAN.

THROUGHOUT THE DURATION OF THE PROJECT. THE CONTRAC-TOR SHALL NOTIFY THE PROJECT ENGINEER IN WRITING OF ALL TRAFFIC RESTRICTIONS AND UPCOMING MAINTENANCE OF TRAFFIC CHANGES. THE CONTRACTOR SHALL ENSURE THE WRITTEN NOTIFICATION IS SUBMITTED IN A TIMELY MANNER TO ALLOW THE PROJECT ENGINEER TO MEET THE REQUIRED TIME FRAMES SET FORTH IN THE TABLE BELOW TO INFORM THE SPECIAL HAULING PERMITS SECTION (Hauling.Permits@dot.ohio.gov) AND THE DISTRICT PUBLIC INFORMATION OFFICE (PIO). THIS NOTIFICATION SHALL BE RECEIVED BY THE PROJECT ENGINEER PRIOR TO THE PHYSICAL SETUP OF ANY APPLICABLE SIGNS OR MESSAGE BOARDS.

INFORMATION SHOULD INCLUDE, BUT IS NOT LIMITED TO, ALL CONSTRUCTION ACTIVITIES THAT IMPACT OR INTERFERE WITH TRAFFIC AND SHALL LIST THE SPECIFIC LOCATION, TYPE OF WORK, ROAD STATUS, DATE AND TIME OF RESTRICTION, DURA-TION OF RESTRICTION, NUMBER OF LANES MAINTAINED, NUMBER OF LANES CLOSED. MINIMUM WIDTH OF DRIVABLE PAVEMENT. IF APPLICABLE. AND ANY OTHER INFORMATION REQUESTED BY THE PROJECT ENGINEER.

FLOODLIGHTING OF THE WORK SITE FOR OPERATIONS CONDUCTED DURING NIGHT TIME PERIODS SHALL BE ACCOMPLISHED SO THAT THE LIGHTS DO NOT CAUSE GLARE TO THE DRIVERS ON THE ROADWAY. TO ENSURE THE ADEQUACY OF THE FLOODLIGHT PLACEMENT. THE CONTRACTOR AND THE ENGINEER SHALL DRIVE THROUGH THE WORK SITE EACH NIGHT WHEN THE LIGHTING IS IN PLACE AND OPERATIVE PRIOR TO COMMENCING ANY WORK. IF GLARE IS DETECTED. THE LIGHT PLACEMENT AND SHIELDING SHALL BE ADJUSTED TO THE SATISFACTION OF THE ENGINEER BEFORE WORK PROCEEDS.

PAYMENT FOR ALL LABOR, EQUIPMENT AND MATERIALS SHALL BE INCLUDED IN THE LUMP SUM CONTRACT PRICE FOR ITEM 614. MAINTAINING TRAFFIC.

SEQUENCE OF CONSTRUCTION

PHASE 1

1. USING LANE AND SHOULDER CLOSURES IN ACCORDANCE WITH MT-102.10 AND D-12 PERMITTED LANE CLOSURES. REMOVE THE EXISTING RUMBLE STRIPS ALONG THE INSIDE SHOULDER OF EASTBOUND I- 90 AND INSTALL ASPHALT SURFACE COURSE BETWEEN STA. 235+00 AND STA. 259+00.

2. SHIFT THE EASTBOUND LANES OF I-90 IN ACCORDANCE WITH MT- 102.10 AND PLACE PORTABLE BARRIER TO THE LIMITS INDICATED IN THE PLANS.

3. REMOVE 10' OF THE EXISTING 21" PIPE AT THE OUTLET END AT STA. 251+05, RT. DRILL THE KING PILES ADJACENT TO THE LATERAL AND FILL THE PLUG PILE TO THE APPROXIMATE PIPE INVERT. INSTALL THE NEW CONDUIT THROUGH THE WALL AND FORM ABOVE THE CONDUIT. FILL THE PILE TO THE FINAL HEIGHT.

ALL COSTS INVOLVED IN PLACING THE PORTABLE BARRIER WILL BE INCLUDED IN THE CONTRACT PRICE BID FOR ITEM 622 PORTABLE BARRIER, UNANCHORED.

THE CONTRACTOR SHALL FURNISH. INSTALL. MAINTAIN AND REMOVE, WHEN NO LONGER NEEDED, A CHANGEABLE MESSAGE SIGN. THE SIGN SHALL BE OF A TYPE SHOWN ON A LIST OF APPROVED PCMS UNITS AVAILABLE ON THE OFFICE OF MATERIALS MANAGEMENT WEB PAGE. THE LIST CONTAINS CLASS A AND B UNITS WITH MINIMUM LEGIBILITY DISTANCES OF 800 FEET AND 650 FEET, RESPECTIVELY.

EACH SIGN SHALL BE TRAILER-MOUNTED AND EQUIPPED WITH A FUNCTIONAL DIMMING MECHANISM. TO DIM THE SIGN DURING DARKNESS, AND A TAMPER AND VANDAL PROOF ENCLOSURE. EACH SIGN SHALL BE PROVIDED WITH APPROPRIATE TRAINING AND OPERATION INSTRUCTIONS TO ENABLE ON-SITE PERSONNEL TO OPERATE AND TROUBLESHOOT THE UNIT. PLACEMENT, OPERATION, MAINTENANCE AND ALL ACTIVATION OF THE SIGNS BY THE CONTRACTOR SHALL BE AS DIRECTED BY THE ENGINEER. THE PCMS SHALL BE LOCATED IN A HIGHLY VISIBLE POSITION YET PROTECTED FROM TRAFFIC. THE CONTRACTOR SHALL. AT THE DIRECTION OF THE ENGINEER. THE ENGINEER SHALL BE PROVIDED ACCESS TO EACH SIGN UNIT AND SHALL BE PROVIDED WITH APPROPRIATE TRAINING AND OPERATION INSTRUCTIONS TO ENABLE ODOT PERSONNEL TO OPERATE AND TROUBLESHOOT THE UNIT. AND TO REVISE SIGN MESSAGES. IF NECESSARY.

THE CONTRACTOR SHALL IMPLEMENT A SYSTEM WHEREBY CHANGEABLE MESSAGES WILL BE IMPLEMENTED WITHIN 12 HOURS FOLLOWING TELEPHONE NOTIFICATION FROM THE PROJECT ENGINEER TO A DESIGNATED PHONE.

ALL MESSAGES TO BE DISPLAYED ON THE SIGN WILL BE PROVIDED BY THE ENGINEER. A LIST OF ALL REQUIRED PRE-PROGRAMMED MESSAGES WILL BE GIVEN TO THE CONTRACTOR AT THE PROJECT PRECONSTRUCTION CONFERENCE. THE SIGN SHALL HAVE THE CAPABILITY TO STORE UP TO 99 MESSAGES. MESSAGE MEMORY OR PRE-PROGRAMMED DISPLAYS SHALL NOT BE LOST AS A RESULT OF POWER FAILURES TO THE ON-BOARD COMPUTER. THE SIGN LEGEND SHALL BE CAPABLE OF BEING CHANGED IN THE FIELD. THREE-LINE PRESENTATION FORMATS WITH UP TO SIX MESSAGE PHASES SHALL BE SUPPORTED. PCMS FORMAT SHALL PERMIT THE COMPLETE MESSAGE FOR EACH PHASE TO BE READ AT LEAST TWICE.
